 To the implementation of the package of energy saving measures identified in Option A of the report (as illustrated below) delivering annual savings of £109k (Full Year)

Replace 1,597 lighting units, 68 non residential and 1,529 residential (on main traffic routes) luminaires with LEDS	401	109	3.68

• That in light of the ongoing potential to reduce energy and carbon costs by investing in further packages of LED replacement lighting, a further report be brought forward to Cabinet during 2015/16 setting out options for potential further investment during 2016/17.

## 2. REASON FOR THE DECISION BEING MADE:

- The Council operates a system of street lighting across the County Borough comprised of 28,600 street lights. These installations require regular maintenance, consume energy and attract carbon taxation. LED lighting offer benefits over conventional lighting by delivering reduced maintenance costs due to the extra longevity of the units. LED units also consume less energy and therefore attract lower carbon taxation costs.
- The need for Cabinet to consider the service change proposals required as part of the Councils Medium Term Service planning arrangements, specifically in the context of the need to reduce spend and enable the Council to fulfil its statutory responsibility and set a balanced budget from 2016 /2017.
