Mae Chwaraeon RhCT mewn partneriaeth â Chwaraeon Cymru a'r Cyrff Llywodraethu Cenedlaethol, yn argymhell bod pob clwb, darparwr chwaraeon a darparwr chwaraeon masnachol i gyd yn cyflawni safonau gweithredu gofynnol er mwyn diogelu eu haelodau.

Ar ôl derbyn statws 'Chwaraeon Diogel', bydd eich sefydliad neu'ch clwb yn:

1. Derbyn tystysgrif i'w harddangos yn y clwb/sefydliad
2. Derbyn llythyr o gadarnhad
3. Datganiad i'r wasg Chwaraeon Diogel a/neu Insport
4. Cael ei hysbysebu ar www.sportrct.co.uk
5. Cael blaenoriaeth o ran cael cymorth gan wasanaethau Chwaraeon RhCT
6. Cael cymorth o ran datblygu partneriaethau ag ysgolion

Os nad yw'ch clwb yn bodloni'r safonau gweithredu ar hyn o bryd, cysylltwch â Chwaraeon RhCT am gymorth.

Safe Sport status is your way of demonstrating that you practice within the guidelines of your National Governing Body and Rhondda Cynon Taf County Borough Council. **Safe Sport is for constituted sports clubs only.**

Sport RCT in partnership with Sport Wales and National Governing Bodies, strongly advocate that all sports clubs, sports deliverers and commercial sports providers achieve minimum operating standards to safeguard their members.

Achieving 'safe sport' status is a minimum standard and we encourage clubs to do more in safeguarding their members.

When you achieve 'safe sport' status your organisation or club will:

1. Receive a certificate to display in the club / organisation
2. Receive a letter of confirmation
3. Safe Sport and/or Insport press release
4. Advertisement on www.sportrct.co.uk
5. Priority support from Sport RCT
6. Support in developing club to school partnerships

If your club does not currently meet the required operating standards please contact Sport RCT for support.

Accreditation process

What does a club need to achieve 'safe sport' status?

1 Rhaid bod pob goruchwyliwr a hyfforddwr wedi cael gwiriad manwl gan y Gwasanaeth Datgelu a Gwahardd. Darparu enwau'r goruchwylwyr a'r hyfforddwyr, ynghyd â'u rhifau gan y Gwasanaeth Datgelu a Gwahardd.
All supervisors and coaches must have a valid enhanced DBS check. Evidence by providing the names of supervisors and coaches and their DBS number.

2 Mae cymwysterau priodol gan bob hyfforddwr, gydag o leiaf prif hyfforddwr ym mhob clwb. Cyflwyno tystysgrifau gan bob aelod o'r staff hyfforddi.
All coaches have the appropriate qualifications with a minimum head coach for each club. Certificates are presented from all coaching staff.

3 Mae nifer briodol o oruchwylwyr/hyfforddwyr ar gyfer nifer y bobl sy'n cymryd rhan.
The club demonstrate they have appropriate supervisor/ coach to participant ratios.

4 Mae swyddog Cymorth Cyntaf ar gael ym mhob sesiwn hyfforddi a chystadleuaeth. Nodi enw'r swyddog Cymorth Cyntaf os ydy clwb yn hyfforddi ar ei safle ei hun.
A first aider is available at every training and competition meeting. Name of first aider is provided if club train on their own ground/facility.

5 Mae Swyddog Lles Plant ar gael. Gall hyn fod yn rhywun sy'n gweithio ar y safle lle mae'r gweithgaredd yn cael ei gynnal.

There is a designated Child Welfare Officer. This could be someone from the site in which the activity/sport is being delivered in.

Mae polisi yswiriant atebolrwydd cyhoeddus gan y clwb. Mae'n angenrheidiol bod y clwb yn aelod o'r Corff Llywodraethu Cenedlaethol os ydyn nhw'n cynnal chwaraeon risg uchel. Naill ai drwy ddangos aelodaeth o'r Corff Llywodraethu Cenedlaethol neu gopi o dystysgrif polisi yswiriant atebolrwydd cyhoeddus.
The club has public liability insurance. For high risk sports it will be essential the club affiliate to the National Governing Body. Either through proof of affiliation to the NGB or through providing a copy of the public liability certificate.
