### Section 5: Other Activities and Issues

Treasurer of Trealaw Village Trust, and through various grant applications and other fundraising initiatives have raised in 2013/14 over £21,000 for activities in Trealaw, including craft sessions, extra curricular activities in the schools, health awareness events, environmental awareness raising events, time bank initiatives, community art projects.

Successful proposal to the Spirit of 2013/Fourteen Programme via the Community Foundation in Wales (CFIW) resulted in £250,000 being awarded to the area of Mid Rhondda. Working with a local panel and members of CFIW to distribute this finding through a grant making process.

Negotiated with Rhondda Housing Association re the installation of new kitchen and rewiring at Church Hall.
