- The relocation of Porth Library services to Porth Plaza
- To instruct officers to proactively seek a community asset transfer of the existing Porth Library building and review opportunities to work with local, voluntary and third sector providers to deliver a range of community health and wellbeing initiatives.
- To fund the reconfiguration and relocation of existing fittings and fixtures of the current library service into Porth Plaza (£20,000) from existing one off available resources.
