2. REASON FOR THE DECISION BEING MADE:

The need to consider service change proposals as part of the Council's Medium Term Service Planning arrangements, specifically in the context of the need to reduce spend and enable the Council to fulfil its statutory responsibility and set a balanced budget from 2016/17 onwards. The need to consider all the documentation before Cabinet and information provided by Officers following additional gueries at the meeting, including the results of the consultation exercise and the Equalities Impact Assessments. 3. CONSULTATION UNDERTAKEN PRIOR TO DECISION BEING MADE: As outlined within Section 6 of the report, a consultation exercise was initiated by Cabinet following consideration of the proposal at a Cabinet meeting on the 10th November 2015, with the Consultation running for an eight week period from the 23rd November 2015 - 18th January 2016. A target consultation with service users was undertaken in respect of the Day Nurseries proposals (also for an eight week period). 4.
