## 1. DECISION MADE:

Following the consideration of the report of the Director, Regeneration, Planning & Housing containing exempt information as defined in Paragraph 14 of Part 4 of Schedule 12A of the Local Government Act, 1972 (as amended), namely information relating to the financial affairs of any particular person (including the authority holding that information), it was

#### AGREED:

- 1. To authorise the Director of Corporate Estates to acquire key buildings and land within the five agreed Strategic Opportunity Areas, in consultation with the Cabinet Member for Enterprise Development and Housing and the Cabinet Member for Corporate Services and subject to appropriate business case completion and funding approvals as necessary. The five Strategic Opportunity Areas are:
  - Cynon Gateway Energizing the Region
  - The Wider Pontypridd, Treforest Edge of the City, Heart of the Region
  - Pontypridd Town *Pivotal in the Region*
  - A4119 Corridor: Regional Rhondda Gateway
  - Llanilid on the M4: Driving the Regional Economy

## 2. REASON FOR THE DECISION BEING MADE:

To continue to deliver on the Council's commitment to support the regeneration of communities and encourage investment in economy, as set out in Rhondda Cynon Taf County Borough Council's 2016-20 Corporate Plan "The Way Ahead".

The need to Acquire key sites and buildings, which will give the Council control of and the potential to bring forward the right redevelopment proposals to realise the ambitions for the Strategic Opportunity Areas.
