SUBJECT: FOSTERING SERVICES - REGIONAL COLLABORATION TO CREATE A FRONT DOOR FOR FOSTER CARER RECRUITMENT

## 1. DECISION MADE:

#### Agreed -

Following the consideration of the report of the Group Director, Community & Children's Services containing exempt information as defined in Paragraph 14 of Part 4 of Schedule 12A of the Local Government Act, 1972 (as amended), namely information relating to the financial affairs of any particular person (including the authority holding that information), it was

#### AGREED:

- 1. To note the information contained within the report and to give formal approval to commence specific proposals to work collaboratively with MTCBC to create a regional front door for fostering recruitment enquiries, consisting of a call centre function, recruitment officer and marketing officer.
- 2. To terminate all elements of the current contract arrangements and bring the assessment of potential foster carers back in house to RCTCBC.

## 2. REASON FOR THE DECISION BEING MADE:

The need to provide Cabinet with a proposal to create a Cwm Taf Regional front door for Fostering Services in order to handle all fostering recruitment enquiries, process applications, co-ordinate the marketing function and support potential foster carers through the process of becoming a foster carer.
