SUBJECT: MOUNTAIN ASH TOWN CENTRE: DRAFT REGENERATION FRAMEWORK

1. DECISION MADE:

Following the consideration of the report of the Director, Regeneration, Planning & Housing containing exempt information as defined in Paragraph 14 of Part 4 of Schedule 12A of the Local Government Act, 1972 (as amended), namely information relating to the financial affairs of any particular person (including the authority holding that information), it was

AGREED:

- 1. To the Mountain Ash Town Centre Regeneration Framework as a basis for coordinating and delivering the schemes as set out within the document.
- 2. To initiate a planning application on the proposals to redevelop the site of Rhos Square.
- 3. To take all necessary steps to secure the making, confirmation and implementation of a CPO, if negotiations to acquire the land identified on the plan at Appendix 1 of the report fail.

2. REASON FOR THE DECISION BEING MADE:

To continue to deliver on the Council's commitment to support the regeneration of town centres and encourage private sector investment in the high street economy, as set out in Rhondda Cynon Taf County Borough Council's 2016-20 Corporate Plan "The Way Ahead".
