SUBJECT: The Council's 2021/22 Revenue Budget

1. DECISION MADE:

Agreed -

- 1. To recommend the Budget Strategy to Council on the 10th March 2021, subject to the following amendment:
 - In order to accommodate Cabinet's decision to freeze 3G pitch charges for 2021/22, the allocation of £0.709M of Transition Funding for 2021/22 is amended to £0.711M; and
- 2. To authorise the Director of Finance and Digital Services to amend the level of contribution from the Medium Term Financial Planning and Service Transformation Reserve as a consequence of any change to the Council's resource levels announced in the Final Local Government Settlement.

2. REASON FOR THE DECISION BEING MADE:

The need for Cabinet to consider and amend as necessary the draft budget strategy which they would wish to recommend to Council.

3. LINKS TO CORPORATE PRIORITIES/FUTURE GENERATIONS - SUSTAINABLE DEVELOPMENT:

The draft budget strategy will be a key enabler for the delivery of the Council's Corporate Plan and in doing so will support wider partnership objectives and the Well-Being of Future Generations Act.

The proposed approach to budget consultation for 2021/22 was set out in the Cabinet report dated 13th October 2020. It comprised 2 phases as follows:

Phase 2 - once Cabinet agreed the draft budget strategy, and in light of the provisional local government settlement, then this draft strategy was consulted upon as part of Phase 2.
