1. PURPOSE OF THE REPORT

The purpose of this report is to inform Members of the findings and recommendations of the Committee's Electoral Administration Working Group in relation to the Council's review of the community boundary and electoral arrangements within the County Borough.

2. **RECOMMENDATIONS**

It is recommended that Members:-

- 2.1 Note the content of this report.
- 2.2 Endorse the recommendation of the Electoral Administration Scrutiny Working Group to support the proposed boundary changes as set out at Appendix 2.

3. BACKGROUND

- 3.1 At the meeting of the Corporate Services Scrutiny Committee held on 5th March 2013, the Committee agreed that a Scrutiny Working Group should be formed to assist the electoral service in the implementation of a number of forthcoming issues which included a review of the community boundary and electoral arrangements within the County Borough. The review will consider what changes, if any, are needed to existing community arrangements across the whole of the County Borough.
- 3.2 The review commenced on 1st June 2013 and the first stage involved asking all residents and interested parties to consider the current arrangements and submit their views of support or proposals for change.

3.4 On the 9th September 2013, the Committee's Electoral Administration Scrutiny Working Group, met for the first time to consider the submissions received as a result of the first consultation phase. The recommendations in relation to this first stage of the review were then reported to the Corporate Service Scrutiny Committee on the 8th October 2013.

4. **CURRENT POSITION**

- 4.1 The Working Group (County Borough Councillors G Stacey, E Webster, D W Weeks and R Yeo in attendance) met for the second time on 23rd April 2014
- 4.2 It should be noted that declarations of personal interest were received from County Borough Councillors G Stacey and R A Yeo having both submitted proposals for change.
- 4.3 At the meeting Members considered the second stage submissions and proposals, the details of which are attached as Appendix 1.
- 4.4 The Working Group considered the 13 proposals as set out at Appendix 1 along with 1 additional small proposal relating to the moving of Heritage Way out of Llanilid Community Ward into Llanharan Community Ward and which links with the proposal set out at F2.
- 4.5 The Working Group was informed that there were no adverse comments received in relation to 9 of the proposals. Members were also informed of the positive and negative responses in relation to the remaining 5 proposals and studied the supporting maps.

4.6 The Working Group concluded that all the proposals put forward had merit and would therefore support all the changes proposed.

5. <u>NEXT STEPS</u>

5.1 The Committee are asked to endorse the recommendations of the Working Group and support the proposed boundary changes. However, the final decision on these changes will need to be taken by Council sometime in June.
