127 <u>MEMBERS' QUESTIONS</u>

(a) From County Borough Councillor E.Webster to the Cabinet Member for Corporate Services, County Borough Councillor M.A.Norris

"Can you advise whether the alternate use of any of the land or property that the Council has, or intends to dispose of, has created any manufacturing jobs in the County?"

Response from County Borough Councillor M.A.Norris

"Our property portfolio is assessed on a rolling programme, it is a key part to the delivery of efficiencies to protect frontline services. This year we saved £6M in efficiencies. I can advise Members that the review of the property portfolio provides additional income to the Council but does not provide manufacturing jobs. The only one I can think of is Vision Products which is arms length company to the Council, other than that I cannot think of any other manufacturing jobs, our hands have been tied. Until 1999 we had a broad manufacturing base at Coedcae Lane and Gellihirion which were sold by Plaid Cymru which hampered the ability in creating jobs".

Supplementary Question from County Borough Councillor E.Webster

"My point is that we are losing industrial land, for example, the Chubb site at Maerdy was sold for change of use, most of which was for residential. Are you going to protect our sites in the Upper Rhondda and protect the remaining industrial sites in the Rhondda?"

Response from County Borough Councillor M.A.Norris

"The Chubb site wasn't owned by the Council. It was a Planning issue, which are dealt with on an individual basis. We can't have a policy to say that we are going to deny any planning for housing as we need a mixture which Chubb was".

(b) From County Borough Councillor T.Williams to the Cabinet Member for Children's Services, Equalities and the Welsh Language, County Borough Councillor G.Hopkins

"How does the Council mark LGBT history?"

Response from County Borough Councillor G.Hopkins

"In February, this Council hosted the biggest ever celebrations for LGBT History Month with a range of events in our libraries, performances in our theatres and we flew the rainbow flag. We are going from strength to strength".

Supplementary Question from County Borough Councillor T.Williams

"Clearly the Council takes this seriously. Another important issue is that of pay, what is the Council doing to ensure equality in its approach to pay?"

Response from County Borough Councillor G.Hopkins

"The Council has done a lot on pay and equality. For several years Councillor Webber and others were involved in the WAVE project and I am also very proud that we are an accredited living wage employer which has benefitted over 3,000 staff – that is the real living wage and not the joking living wage of the UK Government.

Following the Notice of Motion that was considered back last year, this Council also supports the WASPI campaign. There is a range of issues where this Council has played a leading role for its employees".

(c) From County Borough Councillor (Mrs.)A.Davies to the Cabinet Member for Council Business and Human Resources, County Borough Councillor M.Webber

"Will the Deputy Leader make a statement on the Council's budget consultation process?"

Response from County Borough Councillor M.Webber

"Over 900 people took part in the consultation process in town centres, roadshows and using the on-line simulator. The Leader of the Council met with representatives of the Older Person's Advisory Group (OPAG) this afternoon - far more people are now engaged in the process which provides valuable feedback for us in preparing the budget strategy in 2017/18".

County Borough Councillor (Mrs.)A.Davies did not wish to ask a supplementary question

(d) From County Borough Councillor (Mrs.)J.S.Ward to the Cabinet Member for Economic Development, Tourism and Planning, County Borough Councillor R.Bevan

"How will the Taff Vale Development impact on the County Borough as a whole?"

Note: As County Borough Councillor (Mrs.)J.S.Ward had submitted her apologies for absence at this meeting, the question was not responded to.

(e) From County Borough Councillor G.Smith to the Leader of the Council, County Borough Councillor A.Morgan

"Will the Leader make a statement on investment across the County Borough?"

Response from County Borough Councillor A.Morgan

"This time last year a decision was taken regarding treasury management where we released ear marked reserves. We have committed funding to visible services. Over the last two years we have upgraded up to 50 play areas and there is £750,000 committed for the year ahead. Three new 3G facilities have been provided at Abercynon, Maerdy and Church Village.

As far as infrastructure is concerned, we have trebled our highways budget over the past three years which has been spent on, for example, the Rhigos Mountain Road, replacing bridges etc.

We have allocated a further £2M to the schools budget.

These are just a few areas that we have invested money and hopefully that will continue."

Supplementary Question from County Borough Councillor G.Smith

"The level of investment being delivered is fantastic and is having positive impact. Work has now started on the new lower school in my area. Future investment in 3G, can the Leader give assurances that a 3G pitch in Porth is to be considered?"

Response from County Borough Councillor A.Morgan

"We are providing 3G pitches on a number of sites and Officers are looking at various funding opportunities for one in Porth. Regarding investment in Porth, there has been a considerable amount, last year saw the delivery of park and ride facilities and further £0.5M to extend that".

129 <u>ALL WALES PENSION FUND INVESTMENT POOLING – JOINT GOVERNANCE COMMITTEE AND INTER AUTHORITY AGREEMENT</u>

In his report, the Group Director, Corporate & Frontline Services provided Members with proposals to establish a Joint Governance Committee (`JGC`), which will oversee the pooling of the investments of the eight Local Government Pension Scheme (`LGPS`) funds in Wales. The report also provided details of the draft Inter Authority Agreement (`IAA`) which the constituent authorities (in their capacity as LGPS administrators) are in the process of agreeing and which would formally establish the JGC.

Following consideration of the proposals as outlined in the report, it was **RESOLVED** –

- To note the content of the draft Inter Authority Agreement (`IAA`)
 attached to the report at Appendix 1 and that delegated authority be
 given to the Group Director, Corporate & Frontline Services in
 consultation with the Chair of the Council's Pension Fund Committee
 and the Director, Legal & Democratic Services to approve and sign the
 final version of the IAA;
- 2. To approve the establishment of a Joint Committee (hereinafter referred to as the Joint Governance Committee (`JGC`)) on completion of the IAA referred to in 1 above, and on the basis of the terms of reference set out in the report;
- 3. To delegate the exercise of certain functions to the Joint Governance Committee as set out in the IAA and to note those matters that are reserved to Council;
- 4. To approve the appointment of the Chair of the Pension Fund Committee and his/her nominated deputy to the JGC as the Council's representative;
- 5. To approve the appointment of Carmarthenshire County Council (Dyfed Pension Fund) to act as the Host Council with the responsibilities set out in the IAA; and
- 6. To delegate authority to the Group Director, Corporate & Frontline Services in consultation with the Director, Legal & Democratic Services to agree any further minor amendments to the IAA.
