18.07.17	Age Connects Morgannwg (ACM) proposal for the Big Lottery funding application for the redevelopment of and community asset transfer of St Mairs Day Centre, Aberdare. (Decision Notice)	In order for ACM to undergo the appropriate consultation process.
19.09.17	Proposal to approve (in principle) a 99 year leasehold transfer of St. Mairs Day Centre, Aberdare to Age Connects Morgannwg (ACM) (Decision Notice)	The need to submit a letter of support for ACM's Big Lottery Funding application by the 26.09.17. (Call in Period was to the 27.09.17)
28.09.17	Public Spaces Protection order (Dog Controls – Aberdare Public Park) 2017 (<u>Decision Notice</u>)	To implement the order simultaneously with the Public Spaces Protection Order that was agreed by cabinet on the 22 nd June 2017, which comes into effect on the 1 st October 2017.

07.09.17	Welsh Governments Town Centre Repayable Funding Scheme (phase 4) (<u>Delegated Decision</u>)	The scheme was launched at the end of July 2017 and clarification on key details of the funding was received from WG during August with a deadline for submission of proposals on 15.09.17.
