135 <u>MEMBERS' QUESTIONS</u>

(a) From County Borough Councillor M.Powell to the Cabinet Member for Environment & Leisure (County Borough Councillor A.Crimmings)

"What is the reasoning behind the restrictions on using photographic equipment in Council run swimming pools?"

Response from County Borough Councillor A.Crimmings

"As a general rule, photographs are not allowed to be taken. However, following the completion of the necessary paperwork, photographs can be taken at events such as parties. There is a policy in place and guidance posters distributed in various parts of the leisure centres".

Supplementary Question from County Borough Councillor M.Powell

"I frequent Porth swimming pool with my daughter who is aged 7. On several occasions I have asked if I could take photographs and on one occasion when my aunt was over from America she would've also liked to have taken photographs of my daughter but on every occasion we were told no. I have recently returned from Australia and it is easy to take photographs of children so that families have memories. With regards to a policy, it has never been conveyed to me. I have had emails going back and fore and never been given the policy.

I find it disquieting when the Lido is encouraging tweets and advertising the out-door pool with photographs of children, why is that the case?"

Response from County Borough Councillor A.Crimmings

"The situation at the Lido is with parental consent. I will arrange for a copy of the policy to be sent to you".

(b) From County Borough Councillor M.Forey to the Leader of the Council (County Borough Councillor A.Morgan)

"Will you make a statement on the Council's investment priorities over the course of this Council term in relation to the Corporate Plan?"

Response from County Borough Councillor A.Morgan

"Clearly the Council's budget still suffers from pressures of continuing austerity, which has been the case since 2011 and during that time we had to reduce our budget by around £11M. If we carry on doing what we were doing in 2011 with the same number of staff and services it would cost £100M more. We have invested strategically over the past number of years, by way of the Corporate Plan. We have invested in our infrastructure and our assets and continued to do that at record levels. In the last financial year we exceeded

£100M in investment in capital projects, it's the first time that has happened since RCT was set up. We have other areas where investment has been made in the Corporate Plan under the three priority areas – People, Place and Economy. Our budget is under pressure and will continue to be under pressure under the Tory Government. There has been big investment in the schools across RCT and new schools are being built in the areas of Rhondda, Cynon Valley and Taff-Ely".

Supplementary Question from County Borough Councillor M.Forey

"Can you comment on the investment specifically in Cynon Valley?"

Response from County Borough Councillor A.Morgan

"I will run through the investment within the Cynon Valley from the top down. The Heads of the Valley from funding from the Welsh Government has seen the dualing of the Heads of the Valleys. A 3G pitch has been installed at Ysgol Rhydywaun. There has been regeneration around The Boot and the Black Lion where we have partnered with Trivallis. Aberdare School, where Councillor Bradwick is the Chair of Governors - £50M development which includes a new athletic track within the Sports development. A new school in Cwmaman. Right across the Cynon Valley there is investment going in. There is also additional investment in terms of Robertstown Industrial Estate from Welsh Government and European funding and Coedely is securing similar levels of funding.

The list that I have gone through is quire exceptional and I could replicate that for Rhondda and Taff-Ely".

(c) From County Borough Councillor K.Morgan to the Cabinet Member for Environment & Leisure (County Borough Councillor A.Crimmings)

"What plans or specific projects does the Council have in place to improve and increase leisure and tourism activities in the north of the Cynon Valley?"

Response from County Borough Councillor A.Crimmings

"The Leader has stolen part of my thunder. In terms of leisure, we have Sobell Sports Centre and the Dare Valley Country Park. There are a huge amount of classes taking place. There is a 3G pitch at Sobell and one in Rhyd y Waun. Also investment in pitches and work is being undertaken in the Welfare. Lots of the play areas have also been refurbished.

The Leader has mentioned the Athletic track. Tourism is not in my portfolio but can I suggest that you have a look at the Destination Plan and look at the plans for Tower. There has been a huge investment in the Park and we have got boats back on the lake. There is lots going on there and I recently attended a meeting to look at further proposals.

Supplementary Question from County Borough Councillor K.Morgan

Thank you for your response. I am encouraged that there are some plans to address the detrimental impact of heavy industry and low employment industries in the North of the Cynon Valley and look forward to implementation of them.

There is however one area in particular which could increase leisure and tourism activities if improved now.

The length of the Cynon Trail known locally as the Tramway (specifically between Penywaun and Hirwaun) has been crying out for improvements for many years.

Due to lack of maintenance it is referred to by residents and visitors as the dirtiest, most unpleasant part of the trail to walk, run or cycle on.

Aside of the cleanliness and fly tipping issues, the Tramway has been allowed to deteriorate to a point where I fear restorative costs may now prove prohibitive.

Unlike the Taf Trail, I am advised that there is no programme of planned maintenance and cleansing in place for the Tramway.

Will the Cabinet member pledge a commitment to introducing a planned maintenance schedule for the Tramway and if so, by when?"

Response from County Borough Councillor A.Crimmings

"I will look into it. I work closely with the Cleansing Team and if there is anything that I can do as a Cabinet Member then I will".

(d) From County Borough Councillor G.Caple to the Leader of the Council (County Borough Councillor A.Morgan)

"What discussions has the Council had with Dwr Cymru in respect of its infrastructure works in the Rhondda?"

Response from County Borough Councillor A.Morgan

"There have been lots of conversations. Ian Christie who is the Managing Director is scheduled to come and meet with me next week as a follow up. I have requested a number of things that they can do to inform the public of what's going on e.g. a news letter. They have also agreed to fund a number of aspects such as a section of the highways. There is a post and this person deals with the utilities and a number of points have been raised with that individual, Dwr Cymru are also funding Enforcement Officers on a short term basis. They also made a contribution to Porth Carnival. We have raised concerns on the impact the works are having in Porth, one of which is the closure of the one-way street

The discussions have been extensive, our Officers meet with Welsh Water on a weekly basis and are pro-active adn we do tell them what their obligations are".

Supplementary Question from County Borough Councillor G.Caple

"Are you able to assure businesses that Welsh Water have a plan in place and are addressing the concerns of both residents and businesses in the area?"

Response from County Borough Councillor A.Morgan

"They have appointed a Liaison Officer for this project to try and speak to as many people as possible. The "How to Claim" process has been published and we have asked the Regional Team with Welsh Water to make a further visit so that everyone is absolutely clear that there is a set process for compensation. If they do have an impact – it is comparing this year's takings to last year's to see if there is a variance with income levels. There is a process in place for shop owners to follow".

(e) From County Borough Councillor J.Harries to the Deputy Leader of the Council and Cabinet Member for Council Business (County Borough Councillor M.Webber)

"Will the Deputy Leader please outline what employment opportunities the Council provides to young people in Rhondda Cynon Taf?"

Response from County Borough Councillor M.Webber

"The Council provides a number of key employment opportunities to young people in the County Borough. Our award winning Apprentice Programme and graduates programme offer two year programmes for successful applicants which has had tremendous success over recent years.

Since 2012 we have taken on 163 Apprentices with over 90% securing employme4nt and continuing to progress. Since the commencement of the scheme in 2004, 16 of those have secured employment via this route and a number of them now hold senior management positions.

The intention is to provide at least 150 of those opportunities over the course of this Council term.

We are also continuing to offer opportunities through schemes such as Care 2 Work (care leavers) and Step in the right Direction (young people).

We look wherever possible to provide employment opportunities through the procurement process – procurement contracts awarded to local businesses, where possible, with the postcodes CF, NP or SA as part of our efforts to boost the local economy. This also includes some cases where there is a

local operation supporting the economy but payments are made to a centralised UK address. The percentage of such payments for the 2017/18 financial year was 93.32%. An example of a local large scale procurement scheme was the Church Village Bypass.

We are working closely with the Unions and are looking at an Apprentice Charter"...
