DRAFTING A SCRUTINY WORK PROGRAMME FOR THE 2016/17 MUNICIPAL YEAR

1. PURPOSE OF THE REPORT

To devise a rolling work programme for the Health and Wellbeing Scrutiny Committee for the 2016/17 municipal year.

2. <u>RECOMMENDATIONS</u>

It is recommended that Members of the Health and Wellbeing Scrutiny Committee:

- 2.1 Identify potential work topics and instruct officers to compile relevant information on these areas to enable Committee to determine whether they should be part of the 2016/17 Work Programme;
- 2.2 Agree an initial list of work topics for the 2016/17 Municipal Year (as set out in **Appendix 3**), as informed by the work of the Committee during 2015/16.

3. BACKGROUND INFORMATION

- 3.1 Members will recall that the approach used to assist the Health and Wellbeing Scrutiny Committee in devising a work programme for the 2015/16 municipal year commenced in July 2015 when Members identified a list of service areas/themes that came within the remit of the Committee.
- 3.2 From a long list of topics identified and by applying a set criteria the Committee produced a shortlist of potential topics from which the 2015/16 Work Programme was agreed. Thereafter, the Scrutiny Committee set out a timetable for the delivery of its Work Programme and the method of scrutiny to be applied to each agreed topic area.
- 3.3 Following on, during the 2015/16 municipal year reviews were undertaken in more detail which resulted in recommendations being formulated , the impact of

which was set out in the Overview and Scrutiny 2015/16 Annual Report that was reported to Council on 25th May 2016. This report can be viewed by clicking <u>here</u>.

3.4 Given the size of the 2015/16 Work Programme, it was determined that an element of flexibility would be applied so that topics could be re-visited as the Committee gained a better understanding of the areas assigned to it. In view of this, it was determined that the programme of work should become a 'rolling' work programme.

4. <u>DEVISING A SCRUTINY WORK PROGRAMME FOR THE MUNICIPAL YEAR</u> 2016/17

4.1 To assist Members' thinking when devising their work programme, key sources of information that may be helpful are set out below.

Service areas within the remit of the Committee

4.2 The Terms of Reference for the Committee is to undertake the Overview and Scrutiny role in connection with scrutinising services support the Health and Wellbeing of our communities. The Committee considers Adult Social Services as well as other functions which contribute to the Health and Wellbeing of the County Borough such as Leisure Services and Public and Health and Protection Services.

2015/16 performance results against nationally set performance indicators

- 4.3 **Appendix 1** sets out the Council's 2015/16 performance against <u>nationally set</u> performance indicators that come within the remit of the Health and Wellbeing Scrutiny Committee. Members will note that:
 - The latest all Wales comparative performance information (i.e. relating to 2014/15) has been used together with also including the Council's performance for the previous two financial years; and
- 4.4 Members may wish to consider in more detail where the Council's performance is within the bottom quartile compared to other councils in Wales i.e. 'The Number of visits to local authority sport and leisure centres per 1,000 population'.

Overview and Scrutiny 2015/16 Annual Report

- 4.5 Through its work during 2015/16, the Health and Wellbeing Scrutiny Committee identified a number of areas for on-going attention in 2016/17, as set out in the Overview and Scrutiny Annual Report for 2015/16. These were:
 - Supporting People

- MASH evaluation.
- Leisure Contribution to Health and Wellbeing

Corporate Performance Report 2016/17

- 4.6 Between March and May 2016 three Scrutiny Working Groups were established to assess the Council's performance during 2015/16 and priority action plans for 2016/17, both of which are to be reported to Council on the 29th June 2016 as part of a document called 'Corporate Performance Report 2016/17'. A copy of this report can be viewed by clicking <u>here</u>.
- 4.7 As part of identifying potential work topics, the 'Corporate Performance Report 2016/17' is suggested as a key source of information to inform Members considerations.
- 4.8 In having regard to the above sources of information together with the local knowledge and insight of Members, the Committee may also wish to consider building some flexibility into the Work Programme to be able to accommodate specific referrals, for example, from Cabinet, Audit Committee or the Finance and Performance Scrutiny Committee.
- 4.9 Subject to Members views on potential topic areas, further information will be compiled by Officers to enable the Committee to make informed decisions on the content of its 2016/17 Work Programme. As part of this process, the criteria as set out at **Appendix 2** is proposed to be applied and Members are requested to provide feedback on its adequacy and whether or not amendments are required.

5. INITIAL LIST OF WORK TOPICS FOR THE 2016/17 MUNICIPAL YEAR

5.1 As Members will be aware, the Health and Wellbeing Scrutiny Committee identified a number of topic areas to carry forward from 2015/16 into the 2016/17 Municipal Year. This information has been used to inform the compilation of an initial list of work topics for 2016/17 (and is set out at **Appendix 3**).

5.2 **Pre-Scrutiny**

The Chairs and Vice-Chairs of the Themed Scrutiny Committees were invited to the meeting of the Overview and Scrutiny Committee held on the 5th July, 2016 to contribute to the item in respect of potential topics that could be selected for pre-scrutiny from the Cabinet Work Programme. In the absence of the Chair, the Vice Chair of the Health and WellBeing Scrutiny Committee selected the following topics to undergo pre-scrutiny by the Committee and are also included at Appendix 3:-

• Extra Care Strategy

- Discretionary Empty Property Grants Across RCT
- Director of Social Services Annual Report 2016/17
- 5.3 Members are requested to consider the initial list of topic areas and, if deemed appropriate, approve their inclusion on the Work Programme to enable timely commencement of the Committee's work.

6. <u>Training</u>

6.1 In addition to the fundamental scrutiny skills of questioning, challenging and listening, Members are asked to consider what skills / knowledge could be enhanced to help further improve their impact as a Scrutiny Member, for example, should more regard be paid to the specific topics which feature within the individual Scrutiny Work Programme and focussed training aligned to these?
