
2. System Gylchu Cylchfan Stryd y Bont

- i. Lôn dde-orllewinol dwy lôn y ffordd gerbydau tua'r gogledd o'i chyffordd â slipffordd Stryd y Bont tua'r gogledd, am 14.5 metr i'w chyffordd â Stryd y Bont
- ii. Lôn ddeheuol system gylchu Stryd y Bont rhwng cyffordd y ffyrdd cyswllt tua'r de a'r gogledd am 25 metr

3. Yr A4223, Stryd y Bont

- i. Lôn dde-orllewinol y ddwy lôn o'i chyffordd â chylchfan Stryd y Bont, tua'r gogledd-orllewin am 19.1 metr

**(REVOCATION AND PROHIBITION OF DRIVING
(EXCEPT FOR BUSES, HACKNEY CARRIAGES AND
BICYCLES) ORDER 2019**

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, the effect of which will be to

1. Revoke the "Rhondda Cynon Taff County Borough Council (Bridge Street Roundabout and A4223 Bridge Street, Pontypridd) (Prohibition of Driving Except for Buses Taxi's and Cycles) Order 2012" in its entirety
2. Introduce Prohibition of Driving (except for Buses, Hackney Carriages and Bicycles) on the lengths of roads specified in Schedule 1

A copy of the relevant documents may be inspected during normal office hours at the Principal Offices of the Rhondda Cynon Taff County Borough Council, The Pavilions, Cambrian Park, Clydach Vale, Tonypandy, CF40 2XX and Pontypridd One4All, Sardis House, Sardis Road, Pontypridd, CF37 1DU until 12th July 2019

Objections or representations to the proposal together with the grounds on which they are made must be sent in writing to the Traffic Manager, Sardis House, Sardis Road, Pontypridd, CF37 1DU by 12th July 2019

**SCHEDULE 1 – Prohibition of Driving (Except for
Buses, Hackney Carriages and Bicycles)**

1. Bridge Street, Northbound Slip Road

- i. The western most lane of the three lanes on the Bridge Street, northbound slip road from its junction with Bridge Street roundabout gyratory, southwards for a distance of 37 metres


2. Bridge Street Roundabout Gyratory

- i. The south western most lane of the two lanes northbound carriageway from its junction with the Bridge Street, northbound slip road for a distance of 14.5 metres to its junction with Bridge Street
- ii. The southern most lane of the Bridge Street roundabout gyratory between the junction of the southbound and northbound link roads for a distance of 25 metres

3. A4223 Bridge Street

- i. The south-western most lane of the two lanes from its junction with Bridge Street roundabout, north westwards for a distance of 19.1 metres
