IF063: Abercynon Town Centre – Proposed One Way system and 20 MPH Speed Limit.

Following concerns raised by members of the public regarding the restricted traffic flow on Ynysmeurig Road during peak times, the council have developed proposals to introduce a new one way system through Abercynon town centre. These works will also include alterations to Station Road and Margaret Street to assist the flow of traffic on the proposed arrangements.

Further to this, this council have also drafted plans to introduce a new 20 MPH speed limit to cover the entirety of Carnetown and Glancynon.

The council is writing to all affected residents to advise of the proposed changes to the one way system and provide the opportunity for residents to submit their observations and or make comment.
