**DYMA HYSBYSIAD** bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwiadu gwneud Gorchymynion amrywiol o dan Adranau 1, 2 a 4 o Ddeddf Rheoleiddio Traffig Ffyrrd 1984 ("y Ddeddf"), ar ôl ymgynghori â Phrif Swyddog yr Heddlu yn unol ag Adran 23(2)(a) o'r Ddeddf honno, ac wedi hysbysu Llywodraeth Cymru mewn ysgrifennu, a phob pŵer galluogi arall, a'i effaith fydd:

1. Amrywio'r Gorchymyn Rheoleiddio Traffig sydd wedi'i nodi yn Atodlen 1
2. Cyflwyno Cyfyngiadau Aros ar hyd y ffyrrd wedi'u nodi yn Atodlen 2
3. Sefydlu Croesfan Twcan i Gerddwyr yn y lleoliad sydd wedi'i bennu yn Atodlen 3

**ATODLEN 1 – Amrywiad**

1. Bydd "Adolygiad Gorchymynion Rheoleiddio Traffig 2012 (Strydoedd Amrywiol yn Rhondda Cynon Taf)" yn cael ei amrywio trwy ddileu'r eitemau canlynol o Atodlen 3 – Ardal Taf Elái, Rhan 3 – Gwahardd Aros ar Unrhwyw Adeg, Eitem 68 – Rhyd-yr-helyg (Willowford), Ystad Ddiwydiannol Trefforest:-
  - a. Ochr dde-ddwyreiniol Rhyd-yr-helyg o'i chyffordd ddeheuol â'r Goedlan Fawr (Main Avenue), i'r de-orllewin am bellter o 92 metr
  - b. Ochr ogledd-ddwyreiniol Rhyd-yr-helyg o'i chyffordd ddeheuol â'r Goedlan Fawr, i'r de-orllewin am bellter o 44 metr
  - c. Ochr ogledd-ddwyreiniol Rhyd-yr-helyg o fan 77 metr i'r de-orllewin o'i chyffordd ddeheuol â'r Goedlan Fawr, i'r de-orllewin am bellter o 17 metr
  - d. Ochr ogledol Rhyd-yr-helyg o fan 1 metr i'r gogledd-orllewin o wal derfyn Uned G13 i'r de-ddwyrain am bellter o 30 metr

**ATODLEN 2 – Gwahardd Aros ar Unrhwyw Adeg**

1. **Y Goedlan Fawr, Ystad Ddiwydiannol Trefforest**
  - a. Ochr dde-orllewinol o fan 26.5 metr i'r gogledd-orllewin o'i chyffordd â Rhyd-yr-helyg i fan 26 metr i'r de-ddwyrain o'i chyffordd â Rhyd-yr-helyg, pellter o oddeutu 64 metr
  - b. Ochr ogledd-ddwyreiniol o fan 28.5 metr i'r gogledd-orllewin o'i chyffordd â Chlos Dewi Sant (St David's Close) i fan 20.5 metr i'r de-ddwyrain o'i chyffordd â Chlos Dewi Sant, pellter o oddeutu 58.5 metr
2. **Rhyd-yr-helyg, Ystad Ddiwydiannol Trefforest**
  - a. Ochr dde-ddwyreiniol Rhyd-yr-helyg o'i chyffordd ddeheuol â'r Goedlan Fawr, i'r de-orllewin am bellter o oddeutu 100 metr
  - b. Ochr ogledd-ddwyreiniol Rhyd-yr-helyg o'i chyffordd ddeheuol â'r Goedlan Fawr, i'r de-orllewin am bellter o oddeutu 96 metr
  - c. Ochr ogledol y ffordd gerbydau, o fan oddeutu 6.5 metr i'r de-ddwyrain o ffin ogledd-ddwyreiniol Uned G8 i'r gogledd-orllewin am bellter o oddeutu 30.5 metr
  - d. O fan 28 metr i'r de-ddwyrain o wal derfyn ddeheuol 20 Llys Canol, i'r de-ddwyrain am bellter o 40 metr

**ATODLEN 3 – Croesfan Twcan i Gerddwyr**

Sefydlu Croesfan Twcan dan reolaeth signal yn y lleoliadau a ganlyn:

1. **Y Goedlan Fawr, Ystad Ddiwydiannol Trefforest**
  - a. Mewn man 15 metr i'r de-ddwyrain o'i chyffordd ddeheuol â Chlos Dewi Sant, Rhyd-yr-helyg
  - b. Mewn man 16.5 metr i'r gogledd-ddwyrain o'i chyffordd ddeheuol â Chlos Dewi Sant, Rhyd-yr-helyg
2. **Clos Dewi Sant, Ystad Ddiwydiannol Trefforest**
  - a. Clos Dewi Sant wrth ei gyffordd ddeheuol â'r Goedlan Fawr
3. **Rhyd-yr-helyg, Ystad Ddiwydiannol Trefforest**
  - a. Rhyd-yr-helyg wrth ei chyffordd ddeheuol â'r Goedlan Fawr

**(VARIATION AND WAITING RESTRICTIONS) ORDER 2020 AND  
(TOUCAN PEDESTRIAN CROSSING) NOTICE 2020**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make various Orders under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act and having notified the Welsh Government in writing, proposes the following and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce Waiting Restrictions on the lengths of roads specified in Schedule 2
3. Establish Toucan Pedestrian Crossing at the location specified in Schedule 3

**SCHEDULE 1 – Variation**

1. The "Rhondda Cynon Taff County Borough Council (Various Streets in Rhondda Cynon Taff) Review of Existing Traffic Regulation Orders 2012" shall be varied by the deletion of the following items from Schedule 3 – Taff Ely Area, Part 3 – Prohibition of Waiting At Any Time, Item 68 – Willowford, Trefores Industrial Estate:-
  - a. The south eastern side of Willowford from its southern junction with Main Avenue, south westwards for a distance of 92 metres
  - b. The north western side of Willowford from its southern junction with Main Avenue, south westwards for a distance of 44 metres
  - c. The north western side of Willowford from a point 77 metres south west of its southern junction with Main Avenue, south westwards for a distance of 17 metres
  - d. The north side of Willowford from a point 1 metre north west of the boundary wall of Unit G13, south eastwards for a distance of 30 metres

**SCHEDULE 2 - Prohibition of Waiting At Any Time**

1. **Main Avenue, Trefores Industrial Estate**
  - a. South western side from a point 26.5 metres northwest of its junction with The Willowford to a point 26 metres southeast of its junction with The Willowford, a distance of approximately 64 metres
  - b. North eastern side from a point 28.5 metres northwest of its junction with St Davids Close to a point 20.5 metres southeast of its junction with St Davids Close, a distance of approximately 58.5 metres
2. **The Willowford, Trefores Industrial Estate**
  - a. The south eastern side of The Willowford from its southern junction with Main Avenue, south westwards for a distance of approximately 100 metres
  - b. The north western side of The Willowford from its southern junction with Main Avenue south westwards for a distance of approximately 96 metres
  - c. The northern side of the carriageway, from a point approximately 6.5 metres south east of the north eastern boundary of Unit G8 north westwards for a distance of approximately 30.5 metres
  - d. From a point 28 metres south east of the southern boundary wall of 20 Centre Court, south eastwards for a distance of 40 metres

**SCHEDULE 3 – Toucan Pedestrian Crossing**

Establish a signalled controlled Toucan Crossing at the following locations:

1. **Main Avenue, Trefores Industrial Estate**
  - a. At a point 15 metres southeast of its southern junction with St Davids Close, The Willowford
  - b. At a point 16.5 metres northwest of its southern junction with St Davids Close, The Willowford
2. **St Davids Close, Trefores Industrial Estate**
  - a. St Davids Close at its southern junction with Main Avenue
  - b. The Willowford at its southern junction with Main Avenue
