Dear Sir / Madam,

As you may be aware, the council recently consulted on proposals to introduce a 20mph speed limit, waiting restrictions and crossing facilities in various roads in the Llwynypia area.

21 properties most affected by the introduction of the waiting restrictions were consulted as well as the school.

10 responses were received, 5 in support and 5 objecting to the introduction of waiting restrictions.

While it is considered that the proposed waiting restrictions are necessary to improve visibility for both pedestrians and drivers and it is not recommended to remove all of the proposed restrictions, a review of the proposals shows that it is possible to reduce the extents of the restrictions in Berw Road and School Terrace.

Details of the proposals are shown on the attached drawings T2019/112/1 and 2. You may also wish to view the proposals at www.rctcbc.gov.uk/traffic

The next stage in the process is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 31 January 2020 to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk
