DATGANIAD O'R RHESYMAU

Yn dilyn pryderon ynghylch cyflymder cerbydau ar ffordd y comin ac ar hyd strydoedd eraill yn yr ardal breswyl, datblygwyd cynigion i gyflwyno Cyfyngiadau Terfyn Cyflymder 30 mya ac 20 mya ar hyd ffyrdd amrywiol yn nhref Llantrisant.

Ar hyn o bryd terfyn cyflymder o 40 mya sydd ar ffordd y comin, a 30 mya yw terfyn cyflymder gweddill yr ardal breswyl. Fodd bynnag, ystyrir y bydd terfyn cyflymder 30 mya ar gyfer ffordd y comin a therfyn cyflymder 20 mya ar hyd y strydoedd preswyl eraill yn derfynau cyflymder mwy priodol i'r gymuned a'r amgylchedd.

O ganlyniad i natur y strydoedd cul a diffyg palmantau yn y lleoliad yma yn yr Hen Dref, byddai'n ddoeth cyfyngu mynediad i gerbydau dros 7.5 tonn i rai strydoedd preswyl yn nhref Llantrisant er diogelwch y cyhoedd.

Mae'r mesurau yma wedi'u cynnig dan Ddeddf Rheoleiddio Traffig 1984 er mwyn hwyluso tramwy cerbydau, atal perygl tebygol a gwella diogelwch ar gyfer holl ddefnyddwyr y briffordd.

STATEMENT OF REASONS

Following concerns regarding vehicle speeds on the common road and in other streets around the residential area, proposals have been developed to introduce 30 mph and 20 mph Speed Limit Restrictions in Various Roads Llantrisant Town.

Currently the common road is subject to 40 mph and the other residential area 30 mph however, it is considered that a 30 mph for the common road and 20 mph speed limits in the other residential streets will be more appropriate speed limits for the community and the environment.

Due to the nature of the layout with narrow roads and limited footways in this Old Town location, it is expedient to restrict the use of vehicles over 7.5 Tonne through all the various residential streets in Llantrisant Town for public safety.

These measures are proposed under the Road Traffic Regulation Act 1984 to facilitate the passage of traffic, prevent the likelihood of danger and to improve safety for all highway users.
