Atodlen 2 – Gwahardd Aros ar Unrhyw Adeg

1. **Heol yr Eisteddfa**
 - a. O'r ochr ogledd-ddwyreiniol, o'i gyffordd â Heol Tyntyla, tua'r gogledd-orllewin am 15 metr.
 - b. O'r ochr de-orllewinol, o'i gyffordd â Heol Tyntyla, tua'r gogledd-orllewin am 10 metr.
2. **Parc Tyntyla**
 - a. I'r ddau gyfeiriad o'i gyffordd â Heol Tyntyla, tua'r gogledd-ddwyrain am bellter o 10 metr
3. **Heol Tyntyla**
 - a. O'r ochr ogledd-ddwyreiniol, o bwynt 5 metr i'r de-ddwyrain o'i chyffordd â Pharc Tyntyla, tua'r gogledd-orllewin am bellter o 31 metr
4. **Ffordd Ddienw o flaen Eglwys San Steffan**
 - a. Y ddwy ochr o bwynt 26 metr i'r dwyrain o'i gyffordd â Stryd y Capel, tua'r dwyrain am bellter o 16 metr
5. **Ffordd Ddienw (i'r dwyrain o Rif 42 Heol Gelligaled)**
 - a. Y ddwy ochr o'i chyffordd sy'n wynebu Eglwys San Steffan tua'r de am bellter o 5 metr

**(VARIATION AND WAITING RESTRICTIONS) ORDER
2021**

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic regulation Order specified in Schedule 1
2. Introduce waiting restrictions as described in Schedule 2

Schedule 1 - Variation

1. The 'Rhondda Cynon Taff County Borough Council (Prohibition of Entry Except for Access) (Unnamed Road Fronting St Stephens Church, Ystrad) (Prohibition of Driving) Unnamed Road Adjacent to No. 42 Gelligaled Road, Ystrad) Order 1998" shall be varied by the removal of Article 2

Schedule 2 – Prohibition of Waiting At Any Time

1. **Eisteddfa Road**
 - a. The north eastern side from its junction with Tyntyla Road north westwards for a distance of 15 metres
 - b. The south western side from its junction with Tyntyla Road north westwards for a distance of 10 metres
2. **Tyntyla Park**
 - a. Both sides from its junction with Tyntyla Road north eastwards for a distance of 10 metres
3. **Tyntyla Road**
 - a. The north eastern side from a point 5 metres south east of its junction with Tyntyla Park north westwards for a distance of 31 metres
4. **Unnamed Road fronting St. Stephens Church**
 - a. Both sides from a point 26 metres east of its junction with Chapel Street eastwards for a distance of 16 metres
5. **Unnamed Road (located east of No 42 Gelligaled Road)**
 - a. Both sides from its junction fronting St. Stephens Church southwards for a distance of 5 metres
