
2. Y Ffordd Fynediad Ddienw i Unedau D10 i D16 a The Barn, Y Goedlan Fawr.

- a. I'r ddau gyfeiriad – o'i chyffordd â Heol Crochendy, tua'r de-ddwyrain am bellter o 5 metr.

3. Y Goedlan Fawr

(WAITING RESTRICTIONS) ORDER 2021

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions as described in Schedule 1

Schedule 1 – Prohibition of Waiting At Any Time

1. Heol Crochendy

- a. South eastern side – from a point 10 metres north east of its junction with the Unnamed Access Road to Units D10 to D16 Main Avenue, south westwards for a distance of 84 metres
- b. North western side – from a point 10 metres north east of its junction with the Unnamed Access Road to Units D10 to D16 Main Avenue, south westwards to its junction with Main Avenue


2. The Unnamed Access Road to Units D10 and D16 and The Barn, Main Avenue

- a. Both sides – from its junction with Heol Crochendy, south eastwards for a distance of 5 metres

3. Main Avenue

- a. North eastern side – from the north western side of its junction with Heol
