
1. Heol Abernant, Aberdâr

- a. Yr ochr ogleddol, o bwynt gyferbyn â ffin orllewinol Rhif 39 Heol Abernant sy'n arwain at ffin ddwyreiniol Rhif 25 Heol Abernant. Pellter o tua 75 metr
- b. Yr ochr ogleddol, o ffin gyffredin Mulberry House a Pippins tua chyfeiriad y de-orllewin am bellter o tua 55 metr
- c. Yr ochr ddeheuol, o ffin orllewinol Rhif 1 Rhiw Nant tua chyfeiriad y de-orllewin gan fynd ymlaen dros ei chyffordd â Heol-y-Parc am bellter o tua 27 metr

2. Heol-y-Parc, Aberdâr

- a. Dwy ochr y ffordd gerbydau, o'i chyffordd â Heol Abernant tua chyfeiriad y de-ddwyrain am bellter o tua 8 metr

(WAITING RESTRICTIONS) ORDER 2022

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions as described in Schedule 1

Schedule 1 – Prohibition of Waiting At Any Time

1. Abernant Road, Aberdare

- a. Northern side, from a point opposite the western boundary of No. 39 Abernant Road leading to the eastern boundary of No. 25 Abernant Road. A distance of approximately 75 metres
- b. Northern side, from the common boundary of Mulberry House and Pippins in a general south westerly direction for a distance of approximately 55 metres
- c. Southern side, from the western boundary of No. 1 Rhiw Nant in a general south westerly direction proceeding over its junction with Heol-Y-Parc for a distance of approximately 27 metres

2. Heol-Y-Parc, Aberdare

- a. Both side of the carriageway, from its junction with Abernant Road in a general south easterly direction for a distance of approximately 8 metres
