

**(VARIATION AND WAITING RESTRICTIONS) ORDER 2021**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions as described in Schedule 2
3. Introduce waiting restrictions Monday to Friday 8.30am – 4.30pm as described in Schedule 3

**Schedule 1 – Variation**

1. The “Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012” shall be varied in that the Order referred to in the Schedule of Orders as:-  
“Mid Glamorgan County Council (Dyffryn Road, Rhydyfelin, Pontypridd) (Revocation, Variation and Prohibition of Waiting) Order 1977” shall be varied as follows: -

Part (a) of the schedule shall now read:

**a) Dyffryn Road, Rhydyfelin**

The south eastern side, from its junction with Cardiff Road eastwards and north eastwards to the southern side of its junction with Sycamore Street

**Schedule 2 – Prohibition of Waiting At Any Time**

**1. Dyffryn Road, Rhydyfelin**

- a. South eastern side, from a point 10 metres south of its junction with Cwrt Y Gamlas, north eastwards for a distance of 26 metres

**2. Cwrt Y Gamlas, Rhydyfelin**

- a. North eastern side, from its junction with Dyffryn Road, south eastwards for a distance of 5 metres
- b. South western side, from its junction with Dyffryn Road, south eastwards for a distance of 68 metres

**3. Sycamore Street, Rhydyfelin**


- a. North eastern side, from its junction with Dyffryn Road, south eastwards for a distance of 10 metres

**Schedule 3 – Prohibition of Waiting Monday to Friday 8.30am – 4.30pm**

**1. Dyffryn Road**

- a. South eastern side, from the northern side of its junction with Sycamore Street, to a point 10 metres south of its junction with Cwrt Y Gamlas
