Conybeare Street, Mountain Ash – Proposed Reduction of Prohibition of Waiting At Any Time Restrictions (Double Yellow Lines)

Following longstanding calls in the community in respect to the lack of available on street parking provisions in the areas surrounding Conybeare Street, Mountain Ash. The council has been investigating the possibility of reducing the waiting restrictions on Rheola Street.

Following works carried out by the council to reduce the pavement buildouts on Conybeare Street earlier this year. It is also proposed to reduce the existing waiting restrictions on Conybeare Street and create approximately 8 additional on-street car parking spaces. Details of the proposals are shown on the attached drawing **TM21/012/PN**, which may also be viewed at **www.rctcbc.gov.uk/traffic**

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 24 September 2021, Traffic Services Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk
