P290 – Tynant Road, Beddau – Proposed Pedestrian Crossing

Following longstanding calls in the community regarding the lack of crossing facilities along Tynant Road, Beddau. The council has developed proposals to implement a raised zebra crossing near the Beddau and Tynant Community Library.

To accommodate these proposals. The Council is also proposing to widen several sections of footways in the vicinity of the proposed crossing. The proposed location of the crossing would also require that the existing westbound bus stop outside the Beddau and Tynant Community Library to be relocated to near No. 1 Garth View.

The council is also proposing to upgrade the existing pedestrian crossing near number 28 Tynant Road by increasing its width from 2.4 metres to 4 metres wide and raising the crossing so that it is level with the footpaths.

The council is writing to all affected residents to advise of the proposed changes and provide the opportunity for residents to submit their observations and or make comment.
