

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make various Orders under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Orders specified in Schedule 1
2. Introduce waiting restrictions as specified in Schedule 2
3. Introduce a Bus Stop Clearway as specified in Schedule 3

SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) (Consolidation) Order 2012", shall be varied by the removal of the following orders from the 'Schedule of Orders' in their entirety:-
 - a. "Cross Street And Clydach Road, Clydach Vale (Prohibition Of Waiting) Order 1987"
 - b. "Cross Street And Clydach Road, Clydach Vale (Variation and Prohibition Of Waiting) Order 1988"
 - c. "Marian Street, Clydach Vale (Prohibition Of Waiting) Order 1978"
 - d. "Howard Street, Clydach Vale (Prohibition Of Waiting) Order 1982"
 - e. "Marian Street And Howard Street, Clydach Vale (Variation) And (Prohibition Of Waiting) Order 1989"
 - f. "Court Street, Blaenclydach (Variation) of (Prohibition of Waiting) Order 1999"
 - g. "Court Street and Un-Named Road south of junction of Court Street and Waun Road, Clydach Vale (Prohibition of Waiting) Order 1983"
2. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) (Consolidation) Order 2012", shall be varied by the removal of items 1, 2, 3, 4 and 6 from the schedule of the following Order:
 - a. "Howard Street, Wern Street, Clydach Road, Court Street, Thomas Street, Berw Road, Fern Terrace, Blaenclydach (Prohibition of Waiting) Order 1975"
3. The "Rhondda Cynon Taff County Borough Council (Various Streets in Rhondda Cynon Taff) (Review of Existing Traffic Regulation Orders) 2012" shall be varied by the removal of the following items from "Schedule 1, Part 3, Prohibition of Waiting At Any Time" in their entirety:
 - a. **(Item 14) Court Street Blaenclydach** – the south western side of Court Street and Clydach Road from the western boundary of No.1 Clydach Road eastwards to the eastward boundary of No.90 Court Street
 - b. **(Item 20) Fern Terrace, Blaenclydach** – the western side of Fern Terrace from its junction with Court Street northwards for a distance of 5 metres and the eastern side of Fern Terrace from its junction with Court Street northwards to its junction with Thomas Street
 - c. **(Item 28) Howard Street, Clydach Vale** – the south eastern side of Howard Street from its junction with Wern Street south westwards to the north eastern boundary of No. 40 Howard Street
 - d. **(Item 32) Marian Street, Clydach Vale** – the southern side of Marian Street from the eastern boundary of No. 12 Marian Street eastwards for a distance of 66 metres and the northern side from the common boundary of Nos 114 and 115 eastwards to its junction with Morton Terrace
 - e. **(Item 53) Wern Street, Clydach Vale** – the southern side of Wern Street from its junction with Howard Street eastwards for a distance of 5 metres

SCHEDULE 2 – Prohibition of Waiting At Any Time

1. **Wern Street**
 - a. Southern side, from the property boundary of Nos.34 and 35 to the property boundary of Nos.40 and 41 for approximately 46 metres in a westerly direction
 - b. Southern side, from the western property boundary line of No.60 Wern Street to a point 1 metre east of the property boundary of No.40 Howard Street, a distance of approximately 31.5 metres
 - c. Southern side, from its junction with High Street for a distance of 10 metres in a westerly direction
 - d. Southern side, from the eastern property boundary line of Clydach Vale Primary School to the junction of Taff Terrace, a distance of approximately 65 metres
 - e. Northern side, from a point 2.0 metres east of the property boundary of No.81 to a point 3.5 metres east of the property boundary line of No.105, a distance of approximately 166 metres
2. **High Street**
 - a. Both sides from its junction with Wern Street for a distance of 10 metres in a southerly direction
3. **Howard Street**
 - a. Southern side, from a point 10 metres west of the western boundary line of No.44 Howard Street to a point 4 metres west of the western property boundary line of No.1 Cambrian View (a row of houses within Howard Street) for a distance of approximately 79 metres in a westerly direction
 - b. Southern side, from a point 35 metres west of the western property boundary line of No.1 Cambrian Way (a row on Howard Street) to its junction with Park Street, a distance of approximately 178 metres in a westerly direction
 - c. Northern side, from its junction with Marian Street for a distance of 10 metres in a westerly direction to the Bus Stop Clearway
 - d. Northern side, from a point 29 metres west of its junction with Marian Street for a distance of 50 metres in a westerly direction
4. **Marian Street**
 - a. Northern side, from the easternmost property boundary of No.116 and the property known as Castell-ar-y Bryn to its junction with Morton Terrace in an easterly direction, for a distance of 25 metres
 - b. Southern side, from its junction with Howard Street for a distance of 12 metres in a westerly direction

- c. Both sides, from its junction with the un-named road/lane adjacent to No.96 for a distance of approximately 5 metres in a westerly direction
- d. Both sides, from its junction with the un-named road / lane adjacent to No.97 for a distance of approximately 5 metres in an easterly direction
- e. Both sides, from its junction with the un-named road / lane adjacent to No.71 for a distance of approximately 5 metres in an easterly direction
- f. Both sides, from its junction with the un-named road / lane adjacent to No.70 for a distance of approximately 5 metres in a westerly direction

5. Morton Terrace

- a. Western side from its junction with Marian Street for a distance of 10 metres in a northerly direction

6. Clydach Road

- a. Northern side, from the western side of its junction with Cross Street, to the property boundary line of No.67 and No.68, a distance of approximately 8 metres in a westerly direction
- b. Northern side, from the eastern side of its junction with Cross Street for a distance of 15 metres in an easterly direction
- c. Northern side, from its junction with Glyn Terrace for a distance of 50 metres in a westerly direction
- d. Northern side, from its junction of Glyn Terrace to its junction with North Terrace for a distance of 80 metres in an easterly direction
- e. Southern side, from its junction with Taff Terrace to the property boundary line of No.25 and the Clydach Vale Community Centre building, for a distance of approximately 237 metres in an easterly direction

7. Cross Street

- a. Both sides from its junction with Clydach Road for a distance of 10 metres in a northerly direction

8. Brynheulog Terrace

- a. Both sides, from its junction with Clydach Road for a distance of 10 metres in southerly direction

9. Glyn Terrace

- a. Both sides, from its junction with Clydach Road for a distance of 5 metres in a northerly direction

10. North Terrace

- a. Western side, from its junction with Court Street for a distance of 22 metres in a northerly direction
- b. Eastern side, from its junction with Court Street for a distance of 10 metres in a northerly direction
- c. Both sides, from its junction with Court Street for a distance of 10 metres in a southerly direction

11. Court Street

- a. Southern side, from its junction with Bryn Terrace to the property boundary line of Nos 1 and 2 Clydach Road, for a distance of 138 metres in a westerly direction
- b. Southern side, from the western boundary of No.72 eastwards to the western boundary of No. 69 for a distance of approximately 41 metres
- c. Northern side, from its junction with North Terrace, eastwards to a point 2 metres east of the property boundary line of No. 117 and No.118 (building known as the Marxian Workmen's Club and Institute) for a distance of approximately 30 metres
- d. Northern side, from its junction with Llwynypia Road for a distance of approximately 14 metres in a westerly direction at The Pandy Inn Public House
- e. The southern side, from the western side of its junction with the un-named road adjacent to the gable end of No.34 Court Street, westwards to the property boundary line of No.34 and No.35 Court Street, a distance of approximately 5.6 metres
- f. The southern side, from the eastern side of its junction with the un-named road adjacent to the gable end of No.34 Court Street, eastwards for a distance of 10 metres
- g. Both sides of the un-named road adjacent to the gable end of No.34 Court Street, from its junction with Court Street, southwards for a distance of 10 metres

12. Bryn Terrace

- a. Both sides, from its junction with Court Street for a distance of 5 metres in a southerly direction
- b. Both sides, from its junction with Court Street for a distance of 5 metres in a northerly direction
- c. Both sides, from its junction with Maddox Street for a distance of 5 metres in a southerly direction

13. Maddox Street

- a. Southern side, from its junction with Bryn Terrace for a distance of 5 metres in a westerly direction
- b. Southern side, from its junction with Bryn Terrace for a distance of 5 metres in an easterly direction

14. Unnamed Link Road (between Court Street to the Cambrian Industrial Park distributor road)

- a. Both sides from its junction with Court Street for a distance of 15 metres in a southerly direction
- b. Both sides, from its junction with the Cambrian Industrial Park Distributor Road, for a distance of 15 metres in a northerly direction

15. Fern Terrace

- a. Western side, from its junction with Court Street for a distance of 25 metres in a northerly direction
- b. Eastern side from its junction with Court Street northwards to its junction with Thomas Street

16. Llwynypia Road

- a. Western side, from its junction with Court Street for a distance of approximately 20 metres in a northerly direction
- b. The eastern side, from a point 145 metres north of its junction with the northern side of Church Street for a distance of 25 metres
