Dear Sir/Madam,

Following a comprehensive review of Zone 601, we have come up with proposals to provide a residential parking zone with limited 2 hours, no return within 4 hours (Monday to Saturday, 8 am-6 pm) between Seion Yr Annibynwy and 22 Sion Street, Trawlln. This was brought about due to a belief that the existing resident-only bays within Sion Street are too restrictive in nature. These proposed changes may provide greater flexibility because they permit visitors, health care professionals etc. to park for a short period of time at the aforementioned location.

You will find extra information with regard to the proposed residential parking zone on drawing number: **TM23/155/IC** attached, which may also be viewed on the council's website at www.rctcbc.gov.uk/traffic.

Please note, that whilst the introduction of a residential parking zone may provide benefits to some local residents, they are subject to a variety of conditions in accordance with the council's existing policy. With that being said I have attached a list of frequently asked questions which should provide you with a better understanding of both the positive and negative effects of being included within a residential parking zone.

Your comments are important to us and will help the Council in its decision-making process. For your convenience, a pro forma and postage-paid addressed envelope is enclosed within this information pack. Alternatively, you may wish to respond by e-mail to trafficservices@rctcbc.gov.uk.

However, we do require significant levels of support from local residents for the introduction of a new residential parking zone. Therefore, I would urge all those directly affected by the plans to respond by **4th August 2023**. If I do not hear from you by that date, the council shall assume you are not in support of a residential parking zone outside your property.
