Dear Sir / Madam,

The council has been successful in a bid to the Welsh Government for emergency funding for the provision of a number of highway improvements across Rhondda Cynon Taf in relation to improving road safety and encouraging active travel.

Part of the councils' response was to consider how to improve safety around schools and to look at what measures could be implemented during school pick up and drop off time when school streets are very busy with vehicles.

The council is therefore looking to implement an experimental prohibition of driving order in areas surrounding several schools across RCT, one of which is Trerobart Primary School.

The prohibition of driving restriction will be in place from 8:30 – 9:30am and from 2:00 – 3:30pm Monday to Friday in term time only, with the primary intention to create a safer environment during the school pick up and drop off period and encourage more children and parents to walk to school. It is not the intention to advocate that children and parents use the carriageway to walk on.

It is acknowledged that it is not possible to create a completely traffic free zone and some exemptions are required.

These exemptions will include:-

Residents

Teachers / School Staff

Pupils unable to walk to school because of their Special Education Needs, disability or mobility problems – to be determined by the Headteacher or LEA

Buses contracted to attend the school

Blue Badge holders

Healthcare workers and carers

Postal services

Deliveries

Emergency Service Vehicles

Building, industrial or demolition vehicles

Statutory Undertaker vehicles

Local Authority vehicles including refuse

The benefit of an Experimental Order is that it provides residents with a trial opportunity to see first-hand how the closure will operate over time and submit comments in respect to the changes up to six months from the date of its implementation following which the Council has a further six months to then consider all responses received before having to make the decision as to whether to make the closure permanent or make further changes in accordance with the views of the community. The experimental order can be in place for up to 18 months before a decision has to be made on whether or not it should be made permanent. It can also be removed or amended with immediate effect should it be considered necessary to do so.

Details of the proposals are shown on the attached plan.

It is proposed to introduce these measures from 28<sup>th</sup> March 2022. Your comments are important to the Council and I shall be pleased to receive your observations on these proposals over the coming months.
