Budget Consultation 2012/13

The Council undertook a wide ranging consultation on the budget for 2012/13 where over 500 people and Citizen Panel members took part. The Citizen Panel members were invited to take part online or via a number of focus groups that were held across Rhondda Cynon Taf.

➤ You told us...

- There had been improvements in 2011/12, in waste management and recycling.
- You supported the Council's employment initiatives
- The Council should protect local jobs and frontline services.
- The Council should prioritise the potential impact of the nationally proposed benefit changes.
- Any Council tax rise should be below 3%.



The views we collected provided the Council with key information to consider when writing the budget strategy and deciding on spending priorities and council tax levels. As a result;

- We continued to protect jobs, and created 33 apprenticeships to give young people fixed-term, paid employment and training.
- We continued to protect frontline services.
- The Council is looking closely at the impact that the benefit changes will have across Rhondda Cynon Taf.
- The Council Tax rise was set at 2.49%.

We are undertaking a session in the Autumn to feedback on some of the service investment and improvements that have been taking place.









Leisure Satisfaction Survey

Leisure Services conduct an annual satisfaction survey to establish the public's perception of the services provided and the resulting information is used to drive service improvement. 2011 was the third year that the survey has taken place. Citizen Panel Members were invited to take part in the survey.

➤ You told us...

- The most popular activities were the fitness suite, swimming and aqua fit.
- The staff were friendly (92% good or very good) and helpful (90%).
- The knowledge of staff was good or very good (79%)

 The main issues for improvement were related to cleanliness, maintenance, equipment and information.

➤ What we did next

- Launched plans for the £50m development of the Ynys site in Aberdare
- Launched a brand new awareness-raising campaign
- Began work on a £2.8m regeneration of Llantrisant Leisure Centre
- Launched new and exciting classes including Aqua fit aqua zumba, free-running, diving and much more.



Strategic Equality Plan Consultation

The Council has produced its Strategic Equality Plan to set out how it aims to meet its commitment to equality and how it will meet its legal obligations contained within the Equality Act 2010.

A comprehensive engagement process took place to involve/consult as many people as possible on the Draft Equality Objectives. The Citizens' Panel were asked their views along with a large number of other stakeholders;

➤ You told us...

Feedback was very positive and some clear messages emerged around the need for the Council to address Disability Hate Crime, work with schools, talk to the 'right' people rather than the 'same people' and to raise awareness of the issues with both staff and public.

➤ What we did next

The Equality Objectives were written into the Strategic Equality Plan reflecting the feedback received and a comprehensive action plan has been developed in order to deliver them.

RCT Engagement Strategy - How involved do you feel?

Rhondda Cynon Taf Council, Interlink (Voluntary Sector), Cwm Taf Health Board and South Wales Police, wanted to find out how they could improve the ways in which they engage with the public. The results were to be used to inform a borough-wide Engagement Strategy. Surveys were distributed in various locations around RCT and online links were emailed to the Citizens' Panel.

➤ You told us...

- 75% of respondents did not feel listened to by public organisations.
- 46% of respondents said they were unsure whether their views would make any difference.
- 39% said they had a lack of time.

- 67% of respondents felt their views had not made a difference.
- Over 80% said it was important or very important to have feedback.

> What we did next

A draft Engagement Strategy is now out for consultation. Taking into account the full range of views the following key areas for development were agreed;

- Develop a consistent partnership approach to public engagement.
- Ensure public engagement becomes core business
- Promote and publicise public engagement in Rhondda Cynon Taf.
- Develop better ways of communicating.

Help shape-up Rhondda Cynon Taf Council's leisure service by taking part in its annual customer satisfaction survey.

There is also a section on the performance of the staff, facility presentation and value for money at each of Rhondda Cynon Taf Council's leisure centres. Rhondda Cynon Taf provides 11 leisure centres, including eight swimming pools across the County Borough.
