PROPOSED ROAD SAFETY SCHEME - VARIOUS ROADS, TRALLWN

In response to concerns raised by the community over a number of years, the Council has developed draft proposals to introduce road safety measures throughout Trallwn. The draft proposals include the following:

- The provision of a 20mph speed limit
- Provision of traffic calming features
- Remodelling of parking at Central Square
- Improvements to the junctions at Middle Street/Ralph St and Ralph St/Parade.

The draft proposals have been designed in order to create a low speed environment within which the community can safely travel regardless of whether you wish to walk, cycle, drive or use public transport.

The Council is writing to all affected residents to advise of the proposed changes and provide the opportunity for residents to submit their observations and or make comment.

Details of the changes that are proposed in the vicinity of your property are shown on the attached drawing G-0-7. However, due to the scale of the improvements you may also wish to visit www.rctcbc.gov.uk/traffic where you will be able to view drawing G-0-8 which shows proposals for the rest of Trallwn.

I shall be pleased to receive your observations on these proposals. For your convenience, a pro forma and postage paid addressed envelope is enclosed. Alternatively you may wish to respond by e-mail to trafficservices@rctcbc.gov.uk Responses should be returned with your observations by 25th November 2016. If I do not hear from you by that date, I shall assume that you have no comment to make on the proposals.

Your comments are important to us and will help the Council in its decision making process. Any comments received will help us decide whether to make changes to the proposals and all observations relating to the scheme will be taken into consideration, however the Council will make no formal response to your comments at this stage.
