Fel y gwyddoch efallai, mae'r Cyngor eisoes wedi ymgynghori ynghylch gwahardd arfaethedig llwytho 7.30-9.30 am a 3.00 pm-6:00 pm dydd Llun-dydd Sadwrn, adleoli safle bws a newid amseroedd ar gyfer cyfyngiadau ar aros dim, A4058 Bute Street a High Street Treorci (Sgwâr Stag), gweithredu mewn ymateb i bryderon y gall cerbydau sydd wedi'u parcio yn rhwystrol, gyfyngu ar amligrwydd ac amharu ar lif traffig yn ystod oriau brig.

PROPOSED PROHIBITION OF LOADING 7.30AM-9.30AM AND 2.30PM-6.00PM MONDAY-SATURDAY, CHANGE OF OPERATING TIMES FOR NO WAITING RESTRICTIONS. A4058 BUTE STREET, HIGH STREET AND STATION ROAD TREORCHY (STAG SQUARE).

As you may be aware, the council has previously consulted on Proposed Prohibition of Loading 7.30am-9.30am and 3.00pm-6.00pm Monday-Saturday, relocation of bus stop and change of operating times for No Waiting restrictions, A4058 Bute Street and High Street Treorchy (Stag Square), in response to concerns that parked vehicles may be obstructive, restrict visibility and impede traffic flows at peak hours.

The informal residents and traders consultation raised a number of comments with a majority in support of the changes to Loading and Waiting restrictions however, there was opposition to the relocation of the bus stop.

Taking account of those comments, the option to re-locate the bus stop has been deferred at this time and may be reconsidered following the introduction of the Loading restrictions. It is also proposed that the Loading restrictions become operational from 2:30pm instead of 3:00pm and protect part of Station Road from Stag Square up to the southern side of the bridge deck.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any comments they may have. If you wish to comment on the proposals, you should do so in writing by 22/12/2017, to the Traffic Services Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk
