Re: 20mph Speed Limit Zone & Traffic Calming (Speed Cushions) & Improvements – Wellington Street and Abernant Road, Aberdare as part of the Coleg-y-Cymoedd Development.

Rhondda Cynon Taf County Borough Council has developed proposals to introduce a 20mph Speed Limit Zone on part of Wellington Street and Abernant Road near to the Coleg-y-Cymoedd development. As part of the scheme, the development will also include traffic calming features, a controlled crossing and several uncontrolled crossings.

The scheme comprises a 20mph speed limit change from the current 30mph speed limit (area indicated in blue on the attached plan) with new 20mph signing installed with red surfacing at the new speed limit extents (shown in red).
