**Proposed Prohibition of Waiting At Any Time restrictions and amended restrictions
Various Roads Cwmbach - Residents Consultation**

The Council are currently developing proposals to introduce Prohibition of Waiting At Any Time restrictions and amend restrictions in various roads Cwmbach.

It is proposed to introduce Prohibition of Waiting At Any Time restrictions in Tirfounder Road, Maeshyfydd, Bryn Awelon and Bryngolwg to protect junctions and, provide a passing place in Maeshyfydd where, parked vehicles can be obstructive, prevent traffic flow and reduce visibility. It is also proposed to amend by removing a section of waiting restrictions in Bridge Road where indicated. Details of the proposals are shown on the attached drawing T2015/14/1, which may also be viewed at www.rctcbc.gov.uk/traffic

Your comments are important to us and will help the Council in its decision making process. Any comments received will help us decide whether to make changes to the proposals and all observations relating to the scheme will be taken into consideration, however the Council will make no formal response to your comments at this stage.
