Re: 20mph Speed Limit, Traffic Calming & Improvements to Pedestrian Crossings at Cemetery Road - as part of the Porth Safer Routes in the Community Scheme.

As part of the development for Porth Safer Routes in the Community, the Council is proposing to introduce speed reduction measures by way of traffic calming features. This will include several zebra crossing upgrades as well as a new Zebra Crossing on Cemetery Road. The scheme also comprises a 20mph speed limit, changed from the current 30mph speed limit (as per area indicated in blue on the attached plan) with new 20mph signing installed with red surfacing at the new speed limit extents (shown in red).

The new Zebra Crossing will be raised on a flat top hump and the two existing zebra crossings will be upgraded and be raised onto flat top road humps also. Details of the proposals are shown on the attached drawing **P029 / 200A**.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 11th October 2017, to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk For further information visit www.rctcbc.gov.uk/traffic for details.
