## Notice of Adoption of a Local Development Plan

### Rhondda Cynon Taf Local Development Plan

On 2nd March 2011 Rhondda Cynon Taf County Borough Council adopted a Local Development Plan (LDP) for Rhondda Cynon Taf. The adopted LDP will form the development plan for Rhondda Cynon Taf and will be the basis for decisions on land use planning in this area.

Copies of the adopted LDP, ***the recommendations of the person appointed to hold the independent examination***, the sustainability appraisal report (incorporating the environmental report), the consultation report and a statement indicating how the environmental report etc. has been taken into account are available for inspection free of charge at Sardis House, Sardis Road, Pontypridd and The Pavilions, Clydach Vale, Tonypandy, as well as the One for All Centres at Rock Grounds, Aberdare; Sardis House, Sardis Road, Pontypridd; Treorchy Library, Station Road and Bronwydd House, Porth.

These documents will also be available in the following Libraries throughout Rhondda Cynon Taf, during their opening times;

The LDP became operative on its adoption 2nd March 2011.

A person aggrieved by the LDP who desires to question its validity on the ground that it is not within the powers conferred by Part 6 of the Planning and Compulsory Purchase Act 2004 or that any requirement of that Act or any regulation made under it has not been complied with in relation to the adoption of the LDP, may, within six weeks from 10th March 2011, make an application to the High Court under Section 113 of the 2004 Act.
