1. PURPOSE OF THE REPORT

1.1. This report provides context of the urgent decision required by the Deputy Leader, Cabinet Member of Tackling Poverty, Engagement and Housing, regarding approval of the Community Enabling Fund grant to the Muni Arts Centre, Pontypridd.

2. RECOMMENDATIONS

2.1. Following consideration, to award the Muni Arts Centre £10k out of the Community Enabling fund following the recommendations of the Voluntary Sector Liaison Steering Group and Community Asset Service Transfer Panel.

3. BACKGROUND

- 3.1. The Community Enabling Fund was agreed by Council on the 25th March 2015, as a earmarked amount of £100K to support non-profit distributing voluntary or community groups in developing and delivering alternative models of service delivery and / or the transfer of Council assets to the community.
- 3.2. It was agreed that the applications for the fund would be considered by internal officers, the 'Community Asset and Service Transfer Panel', and external partners, the members of the Voluntary Sector Steering Group. Both groups would provide recommendations to the Deputy Leader of the Council, in order for a decision to be made on awarding the grant amount requested to a group.

4. URGENT DECISION ON THE MUNI ARTS CENTRE APPLICATION

- 4.1. An application to the Community Enabling Fund was received by a community group seeking to run the Muni Arts Centre in Pontypridd in July 2015.
- 4.2. In this case, a lease had already been signed by the Council transferring the asset to the community group, in order for them to run a venue for artistic and creative activities.
- 4.3. The trustees of the group requested £10K of the Community Enabling Fund to enable the successful launch of the venue. The application stated that the fund would be used for refurbishment and signage for the new provision, which was due to launch on the 7th August 2015.

- 4.4. At the joint meeting of the Voluntary Sector Liaison Steering Group and the Community Asset and Service Transfer Group on the 30th July, 2015, it was agreed that a recommendation be put to the Cabinet Member for Tackling Poverty, Engagement and Housing to approve a grant to the value of £10K paid to the Muni Arts Centre.
- 4.5. The Deputy Leader made the decision to approve the decision as 'urgent' under Section 3A of the Leader's Scheme of Delegation. The item was deemed urgent due to the need to protect the viability of the Muni Arts Centre taking forward the Community Asset transfer and the launch of the service on the 7th August 2015.
- 4.6. Apart from in exceptional circumstances, the recommendations of the group will be referred to Cabinet for decision on Community Enabling Fund grant applications in future.
