**SUBJECT:** Re-tender and award of the Home based carers respite service for adults and children.

#### PURPOSE OF REPORT:

Containing exempt information defined in paragraph 14 of Part 4 of Schedule 12A of the Local Government Act, 1972 (as amended), namely information relating to the financial affairs of any particular person (including the authority holding that information).
