**PWNC | SUBJECT: 'Storm Dennis' – Grant Funding Support for Property Renovation; and  
Free School Meals**

**PENDERFYNIAD | DECISION:**

A Cabinet Steering Group (**Major Incident Recovery Board – FEBRUARY 2020 'STORM DENNIS' FLOODING EVENT**) has been established to ensure an Authority-wide approach in the delivery of services and the prioritisation of resources following the major weather incident declared by South Wales Police as result of severe rain and flooding caused by Storm Dennis. The Board will lead business continuity planning in the immediate period following this weather event and will continue to monitor the progress of associated action(s) agreed as part of the recovery plan determined by the Board. This Recovery Board has been established within the Leader's scheme of delegation.

Following the third meeting of the Recovery Board on the 25<sup>th</sup> February 2020, it is proposed to allocate £800,000 in order to provide grant funding for the renovation of flood impacted properties following Storm Dennis. It is also proposed to fund free school meals for children of families living in properties impacted by flooding for a four week period.

This further support will be funded from £150k of the existing allocation to support recovery efforts, as set out in the urgent decisions of the Leader of the Council dated 17<sup>th</sup> and 21<sup>st</sup> February 2020, £150k from donations being received by the Council and the reprioritisation of £500k of existing Prosperity & Development capital funding.

The detail of this support, including eligibility criteria and terms and conditions will be published by the Council shortly.

The reprioritisation of further funding to support this major storm event now takes the total amount allocated from Council resources to over £2M – highlighting the unprecedented scale of the emergency.
