### **DIBEN YR ADRODDIAD | PURPOSE OF THE REPORT:**

The purpose of the report is to provide information regarding an Agreed Syllabus (Attached as Appendix A) to assist in the teaching of religion, values and ethics (RVE) within the curriculum for Wales being adopted in all schools in Rhondda Cynon Taf in accordance with the Curriculum and Assessment (Wales) Act 2021.

The report also seeks approval to adopt the agreed syllabus for RVE as approved by SACRE and the Agreed Syllabus Conference. This syllabus will be reviewed on a five yearly basis.

In accordance with the Council's Scheme of Delegation, this report has been prepared to accompany the intended officer decision of the Cabinet Member for Education and Inclusion Services in accordance with the Council's Constitution.

### AGREED SYLLABUS FOR RELIGION, VALUES AND ETHICS (RVE) FOR RHONDDA CYNON TAF

### REPORT OF DIRECTOR - EDUCATION AND INCLUSION

### 1. PURPOSE OF THE REPORT

- 1.1 The purpose of the report is to provide information on the Council's statutory duties to establish an Agreed Syllabus for Religion, Values and Ethics (RVE).
- 1.2 To provide an update on the content of the Agreed Syllabus (Appendix 1), as recommended by the Approved Syllabus Conference in June 2022.
- 1.3 To seek approval that this Agreed Syllabus is formally adopted in Rhondda Cynon Taf.

### 2. **RECOMMENDATIONS**

It is recommended:

2.1 That the content of the syllabus is noted and it is agreed that this is formally adopted for use within Rhondda Cynon Taf schools and settings maintained by the Local Authority.

### 2. REASONS FOR RECOMMENDATIONS

2.1 RVE is a statutory requirement of the Curriculum for Wales and Curriculum and Assessment (Wales) Act 2021. It is mandatory for the Council to develop and adopt an agreed syllabus for learners between the ages of 3 to 16 in all schools and settings maintained by the Local Authority.



### 4. BACKGROUND

- 4.1 Every Local Authority has a statutory duty to establish an Agreed Syllabus in accordance with the Curriculum and Assessment (Wales) Act 2021.
- 4.2 The main function of the Agreed Syllabus is to assist schools with their delivery of the RVE aspect of the new curriculum for Wales. It also serves to provide a local context and establish a common approach within schools.
- 4.3 The Agreed Syllabus for Religion, Values and Ethics was approved by the Agreed Syllabus Conference on the 30<sup>th</sup> of June 2022.
- 4.4 Once an agreed syllabus has been adopted, all maintained schools and settings are required to have regard to the agreed syllabus including schools of a religious character, in their design of the agreed syllabus element of their RVE provision.
- 4.5. It is worth noting that there is no parental right to withdraw children from RVE within the Curriculum for Wales. Maintained schools nursery age children and funded non-maintained nursery settings must provide RVE for all learners from the age of three from September 2022. The provision of RVE in maintained schools is optional for post 16 learners from September 2027.

The Agreed Syllabus will be effective from September 2022, for RVE in respect of all learners, up to and including year 6. In respect of year 7 learners, schools in the region will have flexibility on whether to roll out the Curriculum for Wales in September 2022, or to roll out the Curriculum for Wales for years 7 and 8 together in September 2023. During the period of curriculum roll out, as a secondary school or setting 'adopts' the Curriculum for Wales Framework for a particular year group, this Rhondda Cynon Taf Agreed Syllabus will supersede the current/legacy Rhondda Cynon Taf Agreed Syllabus. From September 2023, the Agreed syllabus, in respect of years 7 and 8 as all schools and settings will have implemented the Curriculum for Wales for those learners. Thereafter, the phased roll-out of the Curriculum for Wales will continue, and this Rhondda Cynon Taf Agreed Syllabus will supersede the other:

- year 9 learners in September 2024
- year 10 learners in September 2025
- year 11 learners in September 2026



### 5. EQUALITY AND DIVERSITY IMPLICATIONS

5.1 An Equality Impact Assessment is not needed because the contents of the report are for information purposes only.

### 6. WELSH LANGUAGE IMPLICATIONS

6.1 A Welsh Language Impact assessment has been completed. It is deemed that the amendments proposed are demographic neutral and will not negatively impact on the Welsh language.

### 7. CONSULTATION

7.1 The syllabus was created by a group that contained members from a diverse group. No formal consultation was required but the syllabus was shared with a select group of educational professionals for their input.

### 8. FINANCIAL IMPLICATION(S)

8.1 There are no financial considerations as the delivery of RVE will be from existing school resources.

### 9. LEGAL IMPLICATIONS OR LEGISLATION CONSIDERED

9.1 The local authority has statutory duties under the Curriculum and Assessment (Wales) Act 2021.

## 10. <u>LINKS TO THE COUNCIL'S CORPORATE PLAN / OTHER CORPORATE PRIORITIES.</u>

- 10.1 Educational performance has a clear link to the Council's priority of Building a Strong Economy. Improved educational performance will have a positive impact on this priority.
- 10.2 The effective delivery of RVE helps to reduce extremist views and to promote wellbeing in an individual. In turn, this helps to reduce intervention in the future leading to a healthier and more resilient community that values equality both on a local and global scale.



10.3 Embedded in the delivery of RVE is the Welsh culture and language and compliments the delivery in other areas of the new curriculum.

### 11. CONCLUSION

- 11.1 Adoption of this RVE Agreed Syllabus will assist schools to plan and to deliver effective RVE within Rhondda Cynon Taf from the 1<sup>st</sup> of September 2022. It will produce a more consistent approach that will provide a more seamless transition for those changing schools within the academic year.
- 11.2 Adoption will allow the LA to meet its statutory obligations.

# Curriculum for Wales Religion, Values and Ethics



### **Foreword**

As we begin our transition into the new Curriculum for Wales we are reflecting on what we teach, how we teach and why we teach certain topics. It is both a challenge and a source of excitement that we are now tasked with lighting the fire of the imagination and inspiring our learners to expand their knowledge, understanding and wisdom. Perhaps the most challenging and exciting of these is the area of Religion, Values and Ethics (RVE) which is now within the curriculum and is essential for promoting an individual prepared for their life in our diverse and pluralistic world.

Religion, Values and Ethics is a statutory requirement of the Curriculum for Wales and is mandatory for all learners from ages 3 to 16. Whilst part of the Humanities Area, encompassing geography; history; religion, values and ethics; and business studies, these disciplines share many common themes, concepts and transferable skills, and have their own discrete body of knowledge and skills. Schools and settings within Rhondda Cynon Taf are seizing opportunities to develop rich, exciting and innovative RVE within an authentic and purposeful school designed curriculum. All schools and settings will have 'regard to' their locally Agreed Syllabus for RVE when designing and implementing their curriculum.

The Curriculum for Wales is an opportunity to enhance RVE's importance in the role and delivery of RVE in helping to encourage learners' spiritual development. It is acknowledged that 'spirituality' can be religious or non-religious and is a responsibility across the whole curriculum, for the whole learning community in each school and setting, whilst acknowledging the specific significance that exploration of 'spirituality' has within RVE as part of the Humanities Area of Learning and Experience. It is this spirituality that makes a major contribution to wellbeing and can provide the vehicle for resilience to help learners through the many experiences that they will encounter in life.

I would like to take this opportunity to extend my thanks to all those who have been involved in the creation of this document and to those who will subsequently provide support. I would also like to thank the Education workforce in RCT who have worked very hard in the preparation of the new curriculum and who will continue to provide the very highest level of teaching and learning experience as we strive to achieve our mission of 'Excellence in Education and Enhanced Wellbeing for All'.

The law requires that when a new Agreed Syllabus is needed it is written by an Agreed Syllabus Conference (ASC). This is made up of members of the Borough Council who represent the whole community, practising teachers representing educational professionals, and local leaders of various beliefs, both religious and non-religious, who represent their faiths. As Chair of the ASC of Rhondda Cynon Taf (RCT) I have appreciated how they have all worked collaboratively to produce this Agreed Syllabus which I am pleased to present to you on their behalf.

The Welsh Assembly decided to bring together 'Religion, Values and Ethics' (RVE). It has enabled us to create an exciting, totally different syllabus. It recognises that values and ethics flow from our beliefs, whether religious or non-religious, enabling teachers, if they wish, to explore how all three impact each other and shape our lives.

I'm pleased that RVE is set alongside Geography, History, Business and Social Studies as part of Humanities. Beliefs do not exist in a vacuum but in the local, national and international settings, shaping our society and how we do business. Beliefs and societies have shaped and been shaped by the past and are relevant to our present and our future.

The Welsh Assembly and the ASC are committed to subsidiarity. We believe that we have created a syllabus that enables schools of all kinds the flexibility to create stimulating, challenging and enriching lessons appropriate to the whole range of their pupils.

As well as chairing the ASC I am also Chair of the Standing Advisory Council for Religious Education (SACRE) now to be the Standing Advisory Council (SAC).

As a former secondary Head of RE, a retired clergyman and a former primary school Chair of Governors, I am excited by the potential of this syllabus for our pupils, but I have no illusions about the scale of the challenge facing our teachers as they implement it.



The SAC is committed to do all it can to support our schools in delivering this new syllabus. This SAC will be a forum where representatives of teachers, the

Local Authority, faith groups and a SAC and RVE Adviser from the CSC will meet at least once a term to wrestle creatively with these challenges to seek to ensure that our schools get the best possible support to produce the highest quality education for our pupils across the borough.

We've accepted RCTCBC's offer of space on their website to share links to resources, courses and information that teachers might find helpful. We hope that teachers and faith leaders will send us suggestions. Everything will be vetted by our CSC SAC Adviser to ensure quality and appropriateness.

Please would those seeking to implement this Syllabus let us know if there is anything you think that we can do to help you or if you would like us to hold one of our meetings in your school, so that we can see your excellent work or the challenges you are facing within RVE.

We wish all those involved in any way with RCT education every success as they seek to continue to create excellence in all our schools.

### Rhondda Cynon Taf Agreed Syllabus for Religion, Values and Ethics

### **Audience**

The Rhondda Cynon Taf Religion, Values and Ethics (RVE) Agreed Syllabus has been written to be accessible to all those responsible for designing and delivering the RVE curriculum. The intended audience includes:

- the headteacher of a maintained school or a maintained nursery school
- the governing body of a maintained school or a maintained nursery school
- a provider of funded non-maintained nursery education
- the teacher in charge of a pupil referral unit
- the management committee for a pupil referral unit
- a person who provides teaching and learning for a child, otherwise than at a maintained school, maintained nursery school or pupil referral unit, by virtue of arrangements made under section 19A of the Education Act 1996 (c. 56)
- a local authority in Wales

In addition, the Agreed Syllabus may also be useful to practitioners, regional consortia, awarding bodies, Estyn, teacher unions, religious organisations, non-religious organisations, parents and carers and other bodies in Wales with an interest in RVE.

### **Overview**

### **Agreed Syllabus**

"As RVE is a locally determined subject, the agreed syllabus specifies what should be taught in RVE within each of the 22 local authorities in Wales for those schools that teach the agreed syllabus." RVE Guidance

This document sets out the details regarding teaching and learning in the mandatory element of Religion, Values and Ethics (RVE) in line with the Curriculum for Wales, for all Rhondda Cynon Taf schools and settings maintained by the local authority. This document has been adopted as the Agreed Syllabus for RVE in Rhondda Cynon Taf, in accordance with the Curriculum and Assessment (Wales) Act 2021.



Rhondda Cynon Taf Local Authority have adopted this document as the Agreed Syllabus for RVE in July 2022, following a formal recommendation to the Local Authority by the Agreed Syllabus Conference (ASC) on the 30<sup>th</sup> June 2022.

"Once an agreed syllabus has been adopted, all maintained schools and settings are required to have regard to the agreed syllabus including schools of a religious character, in their design of the agreed syllabus element of their RVE provision." RVE Guidance

All maintained schools in Rhondda Cynon Taf, in addition to the mandatory areas of the Curriculum for Wales, are required to 'have regard' to the Agreed Syllabus for RVE when designing their curriculum. The Local Authority has a duty to review the Agreed Syllabus every five years.

The Rhondda Cynon Taf Agreed Syllabus recognises the approach of the Curriculum for Wales Framework is based on the principle of **subsidiarity** and, as such, the Rhondda Cynon Taf Agreed Syllabus recognises and reflects the autonomy of each school and setting in realising its own curriculum.

### **Implementation**

This Rhondda Cynon Taf Agreed Syllabus will be effective from **September 2022**, for Religion, Values and Ethics in respect of all learners, up to and including year 6. In respect of year 7 learners, schools in the region will have flexibility on whether to roll out the Curriculum for Wales in September 2022, or to roll out the Curriculum for Wales for years 7 and 8 together in September 2023. During the period of curriculum roll out, as a secondary school or setting 'adopts' the Curriculum for Wales Framework for a particular year group, this Rhondda Cynon Taf Agreed Syllabus will supersede the current/legacy Rhondda Cynon Taf Agreed Syllabus. From September 2023, this Agreed syllabus, in respect of years 7 and 8 as all schools and settings will have implemented the Curriculum for Wales for those learners. Thereafter, the phased roll-out of the Curriculum for Wales will continue, and this Rhondda Cynon Taf Agreed Syllabus will supersede the other:

- year 9 learners in September 2024
- year 10 learners in September 2025
- year 11 learners in September 2026

### The Rhondda Cynon Taf Agreed Syllabus for Religion, Values and Ethics

The Rhondda Cynon Taf Local Authority welcomes that Religion, Values and Ethics is a **statutory** requirement of the Curriculum for Wales and is **mandatory** for all learners from ages 3 to 16:

### **Mandatory**

"Religion, values and ethics (RVE) is a statutory requirement of the Curriculum for Wales and is mandatory for all learners from ages 3 to 16. RVE forms part of the Humanities Area. This Area encompasses geography; history; religion, values and ethics; business studies. These disciplines share many common themes, concepts and transferable skills, whilst having their own discrete body of knowledge and skills." RVE Guidance



The legal requirement for Religion, Values and Ethics (RVE)

It is essential that Headteachers, senior leaders and governors understand the legal requirements of RVE within the Curriculum for Wales. These can be found in the RVE section of the Summary of legislation.

The guidance on RVE that sits within the Humanities Area on Hwb, is statutory guidance:

"The guidance on RVE contained within the Humanities Area is statutory and published under section 71 of the Curriculum and Assessment (Wales) Act 2021 (the Act) and designed to assist those responsible under the Act for designing the RVE syllabus as part of the school curriculum." RVE Guidance

The Rhondda Cynon Taf Agreed Syllabus follows the statutory Religion, Values and Ethics <u>Statutory Guidance</u> on Hwb and forms the basis of this Rhondda Cynon Taf Agreed Syllabus and is to be read in conjunction with this document.

The statutory RVE guidance, forms the basis of this Rhondda Cynon Taf Agreed Syllabus for RVE and includes vital information for schools when designing their curriculum at a local level, including the following areas:

Rhondda Cynon Taf schools and settings supports the view that in accordance with the Curriculum and Assessment (Wales) Act 2021 this Rhondda Cynon Taf Agreed Syllabus reflects that:



- the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales
- the fact that a range of non-religious philosophical convictions are held in Wales. As noted in the RVE Guidance on Hwb, non-religious philosophical convictions "include beliefs such as humanism, atheism and secularism" RVE Guidance

Rhondda Cynon Taf schools and settings are also to take note of the following legislative changes which will have a significant impact on schools:

- There is no parental right to withdraw their children from the academic subject of RVE within the Curriculum for Wales.
- Maintained schools with nursery age children and funded nonmaintained nursery settings must provide RVE for all their learners from age 3 from September 2022
- Post 16 RVE in maintained schools is optional for sixth formers from September 2027

### **Designing your RVE Curriculum**

The starting point for any curriculum design is <u>Hwb</u>. Any changes will also be made centrally on Hwb, so it is advised that you read and check information on the <u>Curriculum for Wales</u> regularly.

Each school and setting will need to decide how RVE best works within their approach to the Humanities Area. For example, curriculum design can be integrated, multidisciplinary, interdisciplinary or disciplinary. Curriculum design should be evaluated regularly in line with the Curriculum for Wales Framework. All schools and settings must also have regard to this locally Agreed Syllabus for RVE when designing their curriculum.

The area on the <u>Humanities Area of Learning Experience (AoLE)</u> is also crucial for designing your RVE curriculum. Here you will find the following areas:

- 1. Introduction
- 2. Statements of what matters (mandatory)
- 3. Principles of progression (mandatory)
- 4. Descriptions of learning
- 5. Designing your curriculum



The section on 'designing your curriculum' has the following information that you will also find useful:

- Cross-curricular skills and integral skills
- Specific considerations for this Area
- Key links with other Areas
- · Cross-cutting themes

Schools and settings must ensure that sufficient time is allocated to fulfil a meaningful, challenging and engaging learner experience with RVE. The curriculum provision for RVE <u>does not</u> include time and provision given to Collective Worship, they are distinct and separate. Where learners do not opt to study RVE for an external qualification at age 14-16, they are still required to have suitable and appropriate RVE provision, as the **mandatory** requirement is until 16 years.

Suggested Points to Consider for Rhondda Cynon Taf Schools and Settings It is advised that the following questions can be used when <u>designing your curriculum</u> for RVE:

- Have you considered how RVE will work best within the Humanities Area?
- Have you had regard for your agreed syllabus for RVE?
- Does your curriculum design for RVE support the realisation of the four purposes?
- Have you used the statements of what matters for this Area to inform your curriculum design?
- Have you used RVE concepts in your curriculum design?
- Have you considered a range of sub lenses through which to view RVE concepts to support curriculum design?
- Have you considered learning progression in RVE, using the principles of progression and descriptions of learning in the Humanities Area?
- Have you considered the 'learning journeys' provided to support your understanding of progression in relation to RVE?
- Have you reflected on the possible learning journeys of your own learners to support curriculum design for RVE?
- Have you included opportunities in your curriculum design for enriching learner experiences in RVE?



- Have you made key links between RVE and the other areas of learning and experience?
- Have you included opportunities for learners' spiritual development in RVE?
- Does your curriculum design for RVE ensure an appropriate depth, breadth and quality of learning?

### The 'Right to Withdraw' in the Curriculum for Wales

"There is **no** parental right to request that a child is withdrawn from RVE in the Curriculum for Wales." RVE Guidance

In the Curriculum for Wales RVE is a statutory requirement for all learners from age 3 to 16. The timetable for these changes is as follows:

Primary aged learners – September 2022

Year 7 learners – September 2022 OR September 2023, depending on the roll out of the Curriculum for Wales into their school

Year 8 learners - September 2023

Year 9 learners – September 2024

Year 10 learners - September 2025

Year 11 learners – September 2026

This is in line with every other academic subject in the Curriculum for Wales.

Note that parents may still request that their children are withdrawn from 'collective worship' from September 2022, if they wish, as this is distinct and separate from the academic subject of RVE.
