#### 1. DECISION MADE:

### Agreed -

 To propose the draft 2014/15 revenue budget as detailed on Appendix 1 to the report to Council on the 26<sup>th</sup> February, 2014 and to also include a sum of £400,000 to be used to improve the road network by using prudential borrowing and that the Council's second car be removed.

**Noted:** Members received County Borough Councillor R.K.Turner, Chair of Overview and Scrutiny Committee who presented the feedback on the budget consultation process which was undertaken with the Overview and Scrutiny Committee and the four Service Scrutiny Committees.

He indicated that whilst the budget settlements in recent years had been challenging, this year took it to a whole new level as a result of the cuts imposed by the Westminster Government which will see a £1.7 billion reduction in the Welsh budget by 2015/16. This against a backdrop of increased service demands especially in the area of social services. There is a duty on the Council to produce a balanced budget and this year more than ever, it has been necessary to take difficult decisions.

Councillor Turner further stated that, as usual, there was a great deal of debate at all of the Scrutiny Committees with a wide range of views expressed and the comments of the Scrutiny Members were outlined in Appendix 4 to the report.

There was concern amongst Members that the drive for more and more efficiency savings is not sustainable and will impact on services.

Councillor Turner reported that there was an acceptance of the need to maintain the Schools budget but once again a strong theme which came through during the consultation within the Committees, the need for assurance that schools would be advised that they also have a duty to make efficiencies where they can and that these savings be put to constructive use.

Scrutiny was only too aware that the limited resources can only be stretched so far and that there was a reluctant acceptance of the need to increase Council Tax along with Fees and Charges. It was understood that it is a difficult economic climate for the residents of Rhondda Cynon Taf but if there was a wish to protect vital services to the most vulnerable then there was no option.

Finally, Councillor Turner thanked the Cabinet for giving him the opportunity to address the meeting today.
