That the views and comments of the trustees be taken forward as part of the public consultation in respect of the proposal to continue the current PSPO to designate the whole County Borough as a Controlled Drinking Zone and extend the PSPO to designate Aberdare Town Centre and Pontypridd Town Centre (including Ynysangharad War Memorial Park) as Exclusion Zones, prohibiting the ingestion of intoxicating substances in public places.

2. REASON FOR THE DECISION BEING MADE:

The need to consult the trustees of Ynysangharad War Memorial Park on the PSPO currently out for consultation.
