32 INDEPENDENT REVIEWING OFFICER (IRO) REPORT

In his report, the Group Director, Community & Children's Services provided the Board Members with information regarding the discharge of the Independent Reviewing Officer functions for the period 1st April – 30th September 2013/

34 RCT YOUNG CARERS SERVICE AND ANNUAL REPORT 2012-2013

The Board Members were informed of the positive work being undertaken by the Young Carers Service within Rhondda Cynon Taf and they were provided with the Annual Report 2012-2013 in relation to the Service.

Members were pleased to note that due to raising awareness and ensuring that young carers were identified, there had been a 43% increase in contacts during 2012-2013 compared to 2011-2012. Details of the progress made during the year were reported and following consideration of the matter, it was **RESOLVED** to note the report and work undertaken by the Young Carers Service.

35 CSSIW INSPECTION REPORT

In his report, the Group Director, Community & Children's Services advised Members of the outcome of unannounced inspections undertaken at Treherbert, Beddau and Bryndar Children's Homes between July and November 2013 by The Care and Social Services Inspectorate Wales.

Members noted that the inspection reports were very positive about each of the Homes and the efforts made by staff to provide a high standard of care for the looked after young people. Following consideration of the report, it was **RESOLVED** to note the information.
