"In order to effectively meet the needs of our children, young people and their families, we need a strong multi agency approach across the spectrum of service responses from prevention, early intervention, preventing escalation and managing crisis where necessary. Indeed, the new model for Children's Services will be dependent on strong partnership working and I was pleased at a meeting of Cabinet last week to receive the latest update report on the progress being made with the development of the Multi Agency Safeguarding Hub. Cwm Taf LHB, Social Services and the Well-Being Partnership, there is undoubtedly a need for us to work closer, particularly with Health. The Multi Agency Safeguarding Hub brings together a range of safeguarding services and is an excellent example of public services working together for the benefit of our communities."

Supplementary Question from County Borough Councillor J.Bonetto

"I applaud this joined up approach to safeguarding and not aware of any similar approach in Wales, can the Member confirm this?"

Response from County Borough Councillor G.Hopkins

"Similar arrangements have been looked at across Wales, however, Cwm Taf MASH is the most comprehensive in Wales and will clearly put us and partners on the map in our safeguarding role. We must recognise that this approach is not a guarantee for safety to residents but services are talking regularly to each other."

(5) From County Borough Councillor G.Smith to the Leader of the Council (County Borough Councillor A.Morgan)

"Will the Leader make a statement on regeneration?"

Response from the Leader, County Borough Councillor A.Morgan

"Town centre regeneration for many years have been successful in getting funding in Pontypridd and also attracted funding in Porth, Ferndale etc. Officers work hard across the region for European funding. A number of strategic sites have been worked on e.g. Cynon Valley Furnacite which is classed as a large development site with housing, shops and recreational facilities. The Welsh Government announced yesterday £500,000 funding for Pontypridd and maybe at the next Council meeting I can give an update".

"The Council already has a strong track record to support town centres, what is the ambition for the next 12 months?"

"I continue to honour what I said when I became Leader – we have kept and extended free car parking in the Council's car parks during the Christmas period and we are looking to also provide free parking during small business week. We are also continuing to work with Welsh Government and other funding partners to seek and secure funding to allow us to maintain the support we have given to our town centres over recent years".

"This Council should lend its support to the British Legion's Insult to Injury Campaign.

Veterans injured during Service are having to give up most of their compensation to pay for the costs of their social care.

Military compensation is awarded as recompense for the pain, suffering and loss of amenity experienced by injured Service personnel and veterans; it should **not** be treated as normal income.

This Council considers it unfair that War Pensioners are treated differently to other injured veterans. It is also unacceptable that War Pensioners are treated less favourably than civilians who have been injured in the work place, who are able to place compensation awarded into a trust fund. This Council believes this point to not take account of the Armed Forces Covenant, which states that Service personnel, veterans and their families should face no disadvantage as a result of Military Service.

The Council believes such an approach to be unfair and therefore requests the appropriate Scrutiny Committee/s to consider the issue to ensure all

appropriate measures are taken by this local authority to address this issue. This Council also calls upon the Welsh Government to take the steps to address this issue at an all Wales level by providing the necessary guidance to ensure veterans will not in future be penalised in this way."
