(1) From County Borough Councillor L.Walker to the Cabinet Member for Education and Lifelong Learning, County Borough Councillor (Mrs.)E.Hanagan

"Considering the poor Estyn report on the Central South Consortium and the fact that this Council is paying £1.2 million for advice is it value for money?"

In the absence of County Borough Councillor (Mrs.)E.Hanagan at the meeting, the Mayor informed County Borough Councillor Walker that he would receive a written response, in accordance with adopted procedures.

(2) From County Borough Councillor S.Bradwick to the Deputy Leader and Cabinet Member for Council Business and Human Resources, County Borough Councillor M.Webber

"Can the Deputy Leader, make a statement about the Events Programme please?"

Response from the Deputy Leader, County Borough Councillor M.Webber

"Despite savings in this area, we are continuing to offer an extensive events programme such as the `Big Bite` in Pontypridd which attracts a wide range of people".

Supplementary Question from County Borough Councillor S.Bradwick

"The Tour of Britain, I thought was fantastic and the atmosphere was great and my school was involved. Can you provide any information on any future events which are to take place in our town centres?"

Response from the Deputy Leader, County Borough Councillor M.Webber

"The Tour of Britain was a huge success, We recognise the positive impact such events have on traders. I am delighted to confirm that the Council will be supporting events in town centres at Christmas and we will also be holding events in the Rhondda Heritage Park".

(3) From County Borough Councillor S.Powderhill to the Cabinet Member for Environment, Leisure and Culture, County Borough Councillor A.Crimmings

"Can the Cabinet Member please make a statement about the Ponty Lido, the National Lido of Wales?"

Response from County Borough Councillor A.Crimmings

"It has been a success. Over 70,000 visitors from across Rhondda Cynon Taf and beyond. We have had some fantastic visits including the Royal visit. Over 18,000 of those visitors paid for the activities so a lot of money was raised which was higher than predicted in the Business Plan and it is putting RCT on the map."

Supplementary Question from County Borough Councillor S.Powderhill

"I am in agreement about the positives. What I am disappointed with is the continual attitude of certain opposition Members, they continue to make potshot remarks about the lido. Do you share my concern on the future of the lido, should there be a change in the administration?"

Response from County Borough Councillor A.Crimmings

"One hundred thousand visits – if people looked at social media and the book then everything is fantastic, either they fail to see or don't want to see the success, so if there was a political change then it would be a threat to the lido."

"Will the Cabinet Member please provide an update on the development of the former Taff Vale Precinct?"

"What is the Council doing to promote itself as a visitor destination for tourists?"

In the absence of County Borough Councillor R.Bevan at the meeting, the Mayor informed County Borough Councillors S.Carter and R.Yeo that they would receive written responses, in accordance with adopted procedures. In response to a query from a Member, the Mayor also stated that the written responses in respect of the questions as shown at (1), (4) and (5) above, would be emailed to all Members.

49 PRIMARY CARE – CWM TAF LOCAL HEALTH BOARD

Members received Ms.A.Williams, Chief Executive and Dr.C.Jones, Chairman of Cwm Taf Local Health Board.

Ms.A.Williams outlined the challenges of GP recruitment which is affecting the whole of the UK and the changes this has brought about to Primary Care and its workforce.

She reported on funding that had been made available to Cwm Taf Local Health Board, which was being used for the recruitment of GPs under the following two initiatives:-

- To develop a targeted recruitment for GPs in the Rhondda. Working with the University to increase the number of Medical Students in the hope that if trained in South Wales they will stay in the locality.
- Primary Care Support Unit support and working alongside Practices.

Dr.C.Jones commented on the relationships that have developed with Treorchy Comprehensive School, again promoting the initiatives that are in place to open doors for new recruits within the Health Service. Training medical students in the community is a programme that he is working towards with Cardiff University.

Following many questions that were asked by Members and duly responded to by Ms.A.Williams and Dr.C.Jones, the Mayor thanked them both for their attendance and they left the meeting.

53 <u>2018 REVIEW OF PARLIAMENTARY CONSTITUENCIES IN WALES -</u> INITIAL PROPOSALS

The Director, Legal and Democratic Services attached to his report at Appendix 1 a copy of the initial proposals of the Boundary Commission for Wales in respect of the 2018 review of Parliamentary Constituencies in Wales which was published on the 13th September, 2016 and he sought the Council's comments in relation thereto which were to be made by the deadline of the 5th December, 2016.

RESOLVED – That a Working Group comprising 10 Members (5 Labour, 2 Plaid Cymru, 1 Independent, 1 Democratic Alliance (DAG) and County Borough Councillor P.Baccara (unallocated)) be established to give consideration to the proposals of the Boundary Commission for Wales as shown at Appendix 1 and the feedback therefrom be presented to Council at its meeting to be held on the 30th November, in order that a resonse can be made by the deadline of the 5th December, 2016.

54 <u>WELL-BEING OF FUTURE GENERATIONS (WALES) ACT, 2015 – SCRUTINY OF CWM TAF PUBLIC SERVICES BOARD</u>

In his report, the Director, Legal and Democratic Services sought the Council's endorsement of the establishment of a Joint Overview and Scrutiny Committee to scrutinise the Cwm Taf Public Services Board as commended by the Overview and Scrutiny Committee at its meeting held on the 26th September, 2016.

The Director, Legal and Democratic Services reported that in accordance with Minute Nos. 9.6(3) and (4) respectively of the Annual Meeting of the Council

held on the 25th May, 2016, meetings had been held with colleagues in Merthyr Tydfil County Borough Council to investigate the possibility of creating a Joint Overview and Scrutiny Committee to scrutinise the Cwm Taf Public Services Board. The joint approach would avoid duplication of time and resources of the individual authorities designated Scrutiny Committees.

Set out in the report were details of the statutory provisions relating to scrutiny together with the proposed terms of reference of the Joint Overview and Scrutiny Committee.

Following a discussion, it was RESOLVED -

- (1) To endorse the recommendations as set out in (2) (4) below, as commended by Members of the Overview and Scrutiny Committee;
- (2) To agree to the creation of a Joint Overview and Scrutiny Committee comprising elected Members of both Rhondda Cynon Taf and Merthyr Tydfil County Borough Councils to scrutinise the Cwm Taf Public Services Board:
- (3) To agree that in the absence of any statutory guidance for Scrutiny of Public Service Boards, the establishment of the Joint Scrutiny Committee be in accordance with the requirements of Section 58 of the Local Government (Wales) Measure, 2011, regulations and guidance;
- (4) To agree the draft terms of reference as set out in Appendix 2 to the report, and that the Director, Legal and Democratic Services, in consultation with the Chair of the Overview and Scrutiny Committee be given delegated authority to finalise/amend the terms of reference in accordance with the perameters set out herein;
- (5) That when this Authority is to be nominated the position of Chair of the Joint Overview and Scrutiny Committee, the matter be reported back to a meeting of the Council to ascertain whether the post is to be paid.
