**PURPOSE OF REPORT:**

In accordance with the Council's Scheme of Delegation, this report has been prepared to accompany the intended officer decision of Director, Cabinet & Public Relations as described below.

To provide information and detail on the financial support the Council will provide to the Welsh Charity, Menter Iaith to organise and run the one day festival 'Parti Ponty' for 2017 – 2019.




