1. APOLOGIES FOR ABSENCE

Apologies for absence were received from County Borough Councillors G.R.Davies, S.Rees, E.Webster, C.J.Willis and R.Yeo

2. <u>DECLARATIONS OF INTEREST</u>

There were no declarations of interest made at the meeting pertaining to the agenda.

3. RETIRING MAYOR'S REMARKS

The retiring Mayor, County Borough Councillor R.Lewis addressed the Council on his year of office. He thanked the Members of the previous Council and this new Council for giving himself and his Consort, Jamie, the honour of serving the County Borough of Rhondda Cynon Taf. County Borough Councillor R.Lewis stated that he was proud to have been born and bred in the County Borough and had worked in the area.

County Borough Councillor R.Lewis wished to place on record his thanks for the support provided by his Consort, Jamie during the year and also to his Secretary Ann and his Chauffeur, Steve.

County Borough Councillor R.Lewis was pleased to announce that to date, nearly £20,000 had been raised for his five chosen charities.

In response, Members paid tribute to the retiring Mayor, who was commended for all his hard work and efforts during his term of office.

4. <u>ELECTION OF MAYOR OF RHONDDA CYNON TAF COUNTY BOROUGH</u> <u>COUNCIL FOR THE 2017/18 MUNICIPAL YEAR</u>

RESOLVED – that County Borough Councillor M.Tegg be elected as Mayor of the County Borough for the 2017-2018 municipal year.

Following her election, the retiring Mayor presented County Borough Councillor M.Tegg with her chain of office.

The Mayor's Consort, Mr.Larry Barclay, was then presented with the Mayor's Consort chain of office.

On taking the Chair, County Borough Councillor M.Tegg thanked the Members for their support and confidence in electing her as Mayor of the County Borough and stated that she would undertake the role with pride and would be a good ambassador. She then paid tribute to the retiring Mayor.

The Mayor announced her chosen charities for the year, namely:-

- Guide Dogs Cymru

- Y Bwthyn Pallative Care Hospital, Pontypridd
- Friends of the Animals Wales, formerly Friends of the Animals RCT

The Mayor introduced the Reverend Jeffery Thomas, as her Chaplain.

The Mayor was congratulated on her appointment by the Council.

5. <u>APPOINTMENT OF DEPUTY MAYOR OF RHONDDA CYNON TAF</u> COUNTY BOROUGH COUNCIL FOR THE 2017/18 MUNICIPAL YEAR

RESOLVED – that County Borough Councillor S.Powderhill be appointed as Deputy Mayor of the County Borough for the 2017/18 municipal year.

Upon his appointment, the Mayor presented the Deputy Mayor with his chain of office and he was congratulated on his appointment.

6. BLESSING – REVEREND JEFFREY THOMAS

The Mayor called upon Reverend Jeffrey Thomas to offer a blessing.

Note: At this juncture in the proceedings the Mayor, County Borough Councillor M.Tegg left the meeting to attend to her guests and the Deputy Mayor, County Borough Councillor S.Powderhill took the Chair.

7. APPOINTMENT OF THE LEADER OF THE COUNCIL

RESOLVED – That County Borough Councillor A.Morgan be appointed Leader of the Council and to note that County Borough Councillor M.Webber to be appointed as Deputy Leader of the Council

County Borough Councillor A.Morgan thanked Members for supporting his appointment and he also wished to place on record his thanks to former County Borough Councillor Eudine Hanagan who, during her years on the Cabinet had faced many difficult challenges. Her dedication to the role was renowned as even during times of illness she ensured that she covered all her duties. He also wished to thank County Borough Councillor Mike Forey for the years he too had served on the Cabinet and the support he gave to previous Leaders as well as himself.

The Leader reported that whilst, over recent years revenue funding had been reduced resulting in many cuts in service areas having to be made, in recent weeks, this Council was recognised by the Wales Audit Office as being the fastest improving Council in Wales.

County Borough Councillor M.Webber thanked the Council in supporting her appointment as Deputy Leader of the Council and indicated that it was a honour and privilege to be appointe and that she would give 100% commitment to the role.

9. PROPOSED AMENDMENTS TO THE COUNCIL'S CONSTITUTION

In his report, the Director, Legal and Democratic Services sought Members' approval of the proposed amendments to the Constitution and following consideration of the proposals, it was **RESOLVED** -

1. Allocation of Notices of Motion

To allocate the 20 notices of motion as required by Council Procedure Rule 10.2(a) for the 2017-18 Municipal Year as follows:-

- 9 Labour
- 4 Plaid Cymru
- 1 Conservative
- 1 to each of the `Unallocated` Members (x6)

2. Proposed Amendments to the Council Procedure Rules

That the recommendation as outlined in paragraph 5.1 of the report, to amend Council Procedure Rule 9.4 with the addition of a new Procedure Rule 9.4(e) be referred for consideration to the Corporate Governance and Constitution Committee and the proposals therefrom be brought back to a meeting of the Council for determination.

Note: County Borough Councillor M.J.Powell wished to have recorded the fact that he voted against the above motion and voted in favour of the following lost amendment:

"If the person who is being asked the question is not present at the meeting then the question be put to the next meeting to afford the Member asking the question being given the opportunity to ask a supplementary question".

3. For the reasons outlined in paragraph 5.3 – 5.5 of the report, to amend Council Procedure Rule 10 – Motions on Notice and specifically Rule 10.1 Notice – Protocol as follows (proposed addition to existing rule shown in italics)

Protocol

When Motions are submitted under this Rule 10 and signed by more than two Members the first two signatures listed shall be deemed to be those of the Proposer and Seconder. Seconders to notices of motion under this Rule 10 shall be deemed to have given their consent to their names being used. The act by a Member of seconding a notice of motion shall not count against the Seconder's Group, or if unallocated his or her allocation of motions agreed in accordance with Rule 10.2(a).

4. <u>Proposed Amendments to the Overview and Scrutiny Procedure Rules</u>

For the reasons outlined in paragraph 6.1 of the report the Overview and Scrutiny Procedure Rules be amended to introduce new Rule 17.1b relating to the procedures for conduct of `Call-In` meetings as follows:-

17.1b Procedure at Call-In meetings held under Rule 17.1

- (1) Declaration of interest (including whipping declarations)
- (2) Welcome by Chair outlining reason for Call-In meeting as per details recorded on the notice of the Call-In form.
- (3) Chair to invite the three Members who have signed the notice of Call-In form to present their submission(s) to the Overview and Scrutiny Committee as to why they consider the relevant decision should be referred back to the decision maker for reconsideration, having regard to the reasons set out in the `notice of Call-In form`.
- (4) Chair to invite relevant Director(s) to respond.
- (5) Chair to give any Cabinet Member(s) present the opportunity to address the Committee.
- (6) Chair to invite any other Members of the Committee to speak (and with the Chair's permission any non-Committee Members present, who are eligible to attend, and wish to speak).
- (7) If necessary, the Chair to invite any relevant Director/Cabinet Member present to respond to a Member's question.

- (8) Chair to invite one of the three signatories to the Call-In to make a final address to the Committee membership.
- (9) Chair to put the matter to the vote.
- (10) Legal Officer present to summarise the effect of the Committee's decision in accordance with Overview and Scrutiny Procedure Rules 17.1(e) and 17.1(f) and thereafter communicate the Committee's decision to the Secretary to the Cabinet.
- 5. For the reasons outlined in paragraph 6.3 of the report, to amend the final paragraph of Overview and Scrutiny Procedure Rule 17.2(a) as follows:-

Decisions taken as a matter of urgency must be reported to Council on a three monthly cycle, together with the reasons for the decision(s) being urgent.

- 6. <u>Development Control Committee Proposed Amendments</u>
 - 6.1 For the reason outlined in paragraph 7 of the report to rename the Development Control Committee to Planning and Development Committee.
 - 6.2 To note the new legislation which prescribe requirements relating to the size and composition of local authority Planning Committees (and Sub-Committees) in Wales, specifically that such Committees are to comprise no less than 11 Members and no more than 21 Members of the Authority. In relation to this Council and multi-member wards, only one Member of the ward is eligible for appointment to the Planning Committee (or any Sub-Committee).
 - 6.3 For the reason outlined in paragraph 7.5 of the report, to amend Council Procedure Rule 7 to reflect the new legislation requirements as follows:-

Council Procedure Rule 7 – Quorum (amended as shown in italics):

Quorum

Save for meetings of the Development Control/Planning and Development Committee the quorum of a meeting will be one quarter of the whole number of Members.

During any meeting, if the Mayor/Chair counts the number of Members present and declares there is not a quorum present, then the meeting will adjourn immediately. Remaining business will be considered at a time and date fixed by the Mayor/Chair. If he/she does not fix a date, the remaining business will be considered at the next ordinary meeting.

If a Member is on Family Absence and it would be difficult to replace that Member on a temporary basis, the Mayor can request that Member to attend a meeting if it might otherwise be inquorate.

No business is to be transacted at a meeting of the Development Control/Planning and Development Committee unless at least half of the total number of members of the Committee, rounded to the nearest whole number, are present.

6.4 To note the new legislative requirements which explicitly prohibit the use of substitute members in the absence of appointed members on Planning Committees and that this requirement is already incorporated into the Council Procedure Rules by existing Procedure Rule 22 - `Appointment of Substitute Members for Certain Committees`.

Noted: Following a point raised by a Member in relation to a decision taken by Minute No.99(1) of the Council Meeting held on the 11th January, 2017, it was noted that Council Procedure Rule 22 will need to be amended to reflect the resolution contained in Minute No.99(1).

7. <u>Lay Member of Audit Committee</u>

For the reason outlined in paragraphs 8.2 and 8.3 of the report, that Mr.Roger Hull be reappointed as a Lay Member of the Audit Committee for a further term of office until the next County Borough Council elections.

8. That the Director, Legal and Democratic Services amend the Council's Constitution to reflect the required amendments, as detailed above, and to make any consequential changes.
