CALENDAR OF MEETINGS MUNICIPAL YEAR 2017/2018

1. PURPOSE OF THE REPORT

To seek approval of the Calendar of Meetings for the 2017/2018 Municipal Year.

2. **RECOMMENDATIONS**

- 2.1 To note the contents of the report; and
- 2.2 To agree the proposed Calendar of Meetings for the Municipal Year 2017/2018.

3. BACKGROUND

3.1 In accordance with Part 4 of the Constitution, within the section marked Council Procedure Rules, it is required that the Calendar of Meetings for the forthcoming municipal year be presented at the Annual Council Meeting.

4. PROPOSED CALENDAR OF MEETINGS

4.1 Attached is the proposed Calendar of Meetings for the 2017/2018 Municipal Year which includes the proposed dates for the Cabinet, Council, Licensing Committee, Audit Committee and the Planning & Development Committee.

5. FORMAL DIARY MEETINGS

Council

- 5.1 Within the proposed Calendar, Council meetings are, in the main, scheduled on a monthly cycle. It is proposed to include "Open Government" sessions at each meeting.
- 5.2 Following the Council meeting held on the 14th January, 2009 when it was resolved under Minute No.114(1) "That an Annual Leader's debate be part of the calendar of meetings for each municipal year",

the Leader has agreed to this being incorporated into the Council meeting scheduled for Wednesday, 1st November 2017.

Regulatory Committees

- 5.3 The Licensing Committee will meet approximately every 6 weeks. The Licensing Committee will also meet on a quarterly basis as indicated in the Calendar, to deal specifically with issues arising from the Licensing Act 2003. Licensing Sub-Committees, convened under the Licensing Act 2003, will be convened as and when required.
- 5.4 Whilst there is a recess during the month of August, in the interests of efficiency, meetings of the Licensing Committee and the Licensing Sub-Committees can be convened to deal with any urgent business.
- 5.5 Dates have been allocated to the Planning and Development Committee (subject to the approval of the change in this committee's name from Development Control Committee at Agenda item 6) throughout the calendar year to allow for two meetings per month to take place.

Scrutiny Committees

In accordance with the Council's Constitution each of the Scrutiny Committees is required to hold at least 8 meetings during the Municipal Year. At this point in time, the meetings of the Scrutiny Committees are not included in the calendar until discussions have been undertaken with the Chairs and Vice Chairs of the relevant Scrutiny Committees. This will allow for flexibility in the calendar to schedule meetings to suit individual requirements and work programmes.

Audit

5.7 Meetings of the Audit Committee are scheduled in the calendar mostly on a 6 week cycle.

Democratic Services Committee

5.8 It is proposed that the Democratic Services Committee will meet on an ad-hoc basis as, in accordance with the Local Government (Wales) Measure 2011 requirements (Section 15(2)) - it has to meet at least once a year.

Standards Committee

5.9 The Standards Committee will meet as and when necessary in order to deliver its work programme.

Other Committees

5.10 Meetings of the Appointments Committee, the Appeals/Employee Appeals/Chief Officer Appeals Committee, Pension Fund Committee and the Corporate Governance and Constitution Committee will meet as and when required.

Cabinet

5.11 In accordance with the Council's Constitution the Cabinet is required to meet at least 12 times during the Municipal Year.

Cabinet Sub-Committees

5.12 Cabinet Committees will be convened as and when there is sufficient business.

6. SPECIAL MEETINGS

6.1 Special/Extraordinary meetings of Council or Committees may be called, should this be deemed necessary by the Mayor or the relevant Chairman.

7. FUTURE TIMING OF MEETINGS

7.1 In accordance with Section 6 of the Local Government Measure 2011, a survey will be carried out during this Municipal Year to assess Members' preferences regarding the future timing of meetings.
