97 ANNOUNCEMENTS

- (1) County Borough Councillor A.G.Cox wished to congratulate and send best wishes to Llwyncelyn Welsh Medium Primary School who had got through to the finals of Songs of Praise. The school were to be travelling to Bangor to be filmed for the competition, however, the trip had been postponed to March because of the inclement weather.
- (2) County Borough Councillor P.Jarman informed Members that following on from the Council Meeting held on the 17th February, 2018 (Minute No.86(1) refers) when it was announced that Councillor E.Stephens' sister, Rachel Stephens, was to appear on the new TV series `All Together Now`. Rachel had now reached the finals which is to be transmitted on Saturday evening (3rd March, 2018).
- (3) County Borough Councillor D.Grehan stated that he was making this announcement on behalf of Councillor H.Fychan who could not be present this evening, in that Pontypridd Post Office has opened and many people had signed the petition that had been organised by Plaid Cymru. He indicated that this was a short term solution and the Post Office was looking for a long term solution with the continued aid of support from others.
- (4) The Mayor, County Borough Councillor M.Tegg informed Members that she would be leaving this meeting early as she had another engagement to attend.

98 <u>PETITION</u>

County Borough Councillor J.Harries handed in a petition to the Mayor, on behalf of the residents of the Rhondda Fach requesting the re-introduction of the hourly X8 bus service between Maerdy and Cardiff and for a new rail link service to be introduced between Maerdy and Porth.

99 <u>MINUTES</u>

RESOLVED – to approve as a correct record the minutes of the Council Meeting held on the 17th January, 2018, subject to:-

- Councillor H.Fychan being listed as present.
- Councillor J.Harries name being deleted from the list of those Members that made declaration (Minute No.85 refers).
- In response to the supplementary question Minute No.88(c) reading "....the **particular** salt used by the Council does not work if the temperature is below **-9**".

100 STATEMENTS

- (1) The Leader of the Council, County Borough Councillor A.Morgan gave a verbal progress report on the City Deal. He reported that the Cardiff Capital Regional Wider Investment Fund would support a number of schemes including the following and would over time create approximately 25,000 jobs:-
 - The Metro Central Project
 - Regional Housing Investment Fund
 - Digital Strategy
 - Skills for the Future

The Leader of the Council commented on each of the above schemes and reported that in March of this year, each of the ten Local Authorities would be bringing the five year Business Plan for approval to their respective Councils, which has recently been agreed by the Joint Cabinet.

(2) The Leader of the Council, County Borough Councillor A.Morgan informed Members of the arrangements that were in place for the inclement weather which has been forecast over the next 48 hours. All schools within Rhondda Cynon Taf are to be closed on Thursday and Friday, 1st and 2nd March respectively and therefore Home to School Transport had been duly suspended during this period. Meals on Wheels is to be delivered on Thursday (1st March) and frozen meals are to be delivered to those in receipt of Meals on Wheels on Thursday to cover Friday, Saturday and Sunday. Should a red warning be issued by the Met Office, then the Chief Executive would be taking the decision to close Council Offices, Day Centres and Leisure Centres etc.

101 MEMBERS' QUESTIONS

(a) From County Borough Councillor D.Williams to the Cabinet Member for Enterprise, Development & Housing (County Borough Councillor R.Bevan)

"Please will the Cabinet Member provide a progress report on the redevelopment of the Taff Vale site?"

Response from County Borough Councillor R.Bevan

"I will set out the chronological information – the business case was presented to the Cabinet on the 21st November and a report to Council on the 29th November. The proposed footbridge was presented to the Ynysangharad War Memorial Cabinet Committee. £10M regeneration development funding was received in November, 2017 with a full award expected today. Works started on the 8th January.

Key dates as we go forward – in March there will be a visit by the Welsh Minister for Housing and Regeneration. Construction works will also start in March and piling works start in the Spring. Cranes will be put on site this year. Subject to planning consent, work will start in the Summer of 2019 and the target date for completion is Winter 2020".

Supplementary Question from County Borough Councillor D.Williams.

"Thank you on behalf of my Ward and I thank the Administration for the work that has been done in pushing this forward. The work has had a positive instead of a negative response and the comments on Social Media are appalling. Thank you for inviting me to the forum".

Response from County Borough Councillor R.Bevan

"It is important that we set up the forum and we did the same with the Lido. The meetings proved to be successful in the case of the Lido. Knowing the way Social Media operates, it is key that the right information is given to Members".

(b) From County Borough Councillor S.Belzak to the Cabinet Member for Environment & Leisure (County Borough Councillor A.Crimmings)

"Given the decision of the government in Beijing to close the door on January 1st, 2018 to recyclable waste from the UK and the EU27, and given that 65% of recyclable UK plastic waste (plus significant amounts of other categories or recyclable waste) was previously taken by China, what proportion of waste

separated for recycling by residents of Rhondda Cynon Taf does she expect to be actually recycled (as opposed to being incinerated or put into landfill) during the present calendar year of 2018?"

Response from County Borough Councillor A.Crimmings

In relation to dry mix recyclables I wouldn't expect any change or drop in recycling levels on previous years.

We've spent significant effort in establishing alternative markets for the materials long before the January 2018 cut off point by the Chinese Government.

RCT has what is considered a reasonably high quality mixed plastic and fibres grades recyclable - with long term contracts in place. As a result we've had little issue in establishing European and UK outlets for the waste.

The only considerable affect China's refusal to recycle waste will have is to drive the overall market prices down. However, projected tonnage charges still stand nowhere near landfill or incineration costs. Recycling, even at a cost would still be the most desirable both financially and in relation to the waste hierarchy.

On the percentages before and after the changes in recycling collection due to be implemented

- if no change - wouldn't expect recycling levels to go up above current level of 63%

- with the changes I would expect that once the changes have bedded in, to see the figure rise to nearer 70%

Supplementary Question from County Borough Councillor S.Belzak

"Would you agree that there could be an increase in fly tipping?"

Response from County Borough Councillor A.Crimmings

"Hopefully not, RCT Officers are proactive in tracking down offenders and have no hesitation in prosecuting - we've undertaken hard hitting awareness campaigns and the RCT message to any offenders is we will not tolerate fly tipping".

(c) From County Borough Councillor S.M.Powell to the Leader of the Council (County Borough Councillor A.Morgan)

"What discussions have the WLGA had in respect of the impact of Brexit on Local Government?"

Response from County Borough Councillor A.Morgan

"At the Joint Leaders' Board where the 22 Leaders of the Welsh Authorities meet on a monthly basis. There is going to be an impact. We haven't left the EU yet. The work that the WLGA has been doing will continue but there is an office in Brussels which the WLGA is now closing.

There was no Supplementary Question from County Borough Councillor S.M.Powell

(d) From County Borough Councillor D.Grehan to the Deputy Cabinet Member for Prosperity & Well-Being (County Borough Councillor R.Lewis)

"Can the Cabinet Member with responsibility for community centres, the Councillor Rhys Lewis please give us some indication of the life expectancy of Tonyrefail Community Centre now that the group that met there on a daily basis have been forced out of the building?"

Response from County Borough Councillor R.Lewis

"It is the Council's ambition for community centres to offer a range of services to our residents. The `RCT Together` team and others such as the voluntary sector provide advice and support to those centres. You will be aware that Tonyrefail community centre has been used by a group of individuals with learning disabilities, that client group is moving to Gilfach Goch as an assessment was taken of the building and the best fit would be Gilfach Goch. There has been no force enacted or implied, it was an operational decision. There are no plans to close the centre".

Supplementary Question from County Borough Councillor D.Grehan

"My understanding of the situation is that the community centre has failed on Health and Safety grounds. It is a difficult situation for local government – all authorities are failing to bite the Tory government. In light of the axe to close St.George's Day Centre, people are feeling anxious. I am pleased that Tonyrefail community centre has a future. I hope that looking to the future under the Future Generations Act the Council will try to secure community assets. Can you please confirm that whilst a Health and Safety check was being undertaken, they failed to carry out a fire alarm test and yet we have legislation under the Disability Act 1985 so why wasn't this carried out before?"

Response from County Borough Councillor R.Lewis

"I share your sentiments about Tonyrefail which has been brought about by austerity. In terms of the centre, the relocation was due in terms of the access not necessarily health and safety. There is an access issue there but no long term threat to the centre. St.Georges is currently under a consultation process and that falls outside of my portfolio and I suggest you ask the responsible Cabinet Member".

(e) From County Borough Councillor L.M.Adams to the Chair of the Children & Young People Scrutiny Committee (County Borough Councillor S.Rees-Owen)

"Will the Chair of the Children & Young People Scrutiny Committee make a statement on the priorities of your Committee?"

Response from County Borough Councillor S.Rees-Owen

"The priorities of the Children & Young People is exactly that ensuring that the services provided for children and young people across RCT are fit for purpose and identifying areas for improvement. I would refer you to the Committee's Work Programme that has been reported to your Committee and to meetings of the Scrutiny Chairs and Vice-Chairs".

Supplementary Question from County Borough Councillor L.Adams

"I and my Vice Chair have sat in on your Committee and the other Scrutiny Committees to give encouragement and support, do you feel that you are supported?"

Response from County Borough Councillor S.Rees-Owen

"I am a new Chair and there are a lot of new Members on my Committee, in fact 10 out of 11 are new to the Committee. We are learning together. I have a good working relationship with key Officers. I find the meetings of the Scrutiny Chairs and Vice Chairs to be very beneficial as we know what is going on in each other's Committees. I know you and your Vice attend my meetings and I attend meetings of the Overview & Scrutiny Committee. I met with the Cabinet Member for Education & Lifelong Learning this week and that was a Business Meeting and I was able to tell the Cabinet Member what we were doing on my Committee. There was also a meeting with the Wales Audit Office which I attended along with the other Scrutiny Chairs and yourself. I feel well supported".

101 CWM TAF WELL-BEING PLAN 2018-2023

The Chief Executive provided Members with the Public Services Board's `Cwm Taf Well-Being Plan 2018-2023` as required under the Well-being of the Future Generations Act.

The report of the Public Services Board advising Members of the process in drafting the plan was attached to the Chief Executive's covering report at Appendix 1 and appended thereto was the Well-Being Plan.

Following a discussion, it was **RESOLVED** – to note and approve the Cwm Taf Well-Being Plan.

REPORT OF THE DIRECTOR, CABINET & PUBLIC RELATIONS

102 NOMINATION FOR FREEDOM OF THE COUNTY BOROUGH

In his report, the Director of Cabinet & Public Relations advised Members of the deliberations that took place at the meeting of the Freedom of the Borough Working Group held on the 15th February, 2018 where consideration was given to the nomination received in respect of RAF St Athan. At that meeting, members widened the nomination to include both the Royal Air Force and RAF St. Athan in order to recognise the ultimate sacrifice many air force men and women gave for the freedom of the County, also recognising both the Royal Air Force centenary and the RAF St. Athan's 80th Anniversary.

The Director, Cabinet & Public Relations informed Members that following the meeting of the Working Group, advice had been sought from the Royal Air Force in respect of the accolade and Officers were advised that due to Royal Air Force protocol such an accolade could not be accepted.

At the meeting, Members were informed that following informal discussions with the RAF, it was unlikely that the ceremony for the awarding of the Freedom of the Borough would take place during this municipal year and it the event would take place in June, 2018 as it is their Centenary year.

 - ii. A reduction in the budget allowance for the Council Tax Reduction Scheme of £0.500M;
 - iii. Use of the `Medium Term Financial Planning & Service Transformation Reserve` as transitional funding, totalling £1,022M for 2018/19
- 4. To approve Tables 3 and 4 in Section 10 of the report as the basis of allocating resources to the Individual Schools Budget (ISB), to other Council Services, and to meet its corporate financing requirements;
- 5. To agree the Council Tax increase for the financial year ending the 31st March 2019 at 3.30%;
- 6. To agree the Council's overall budget for 2018/2019, in order to set the Council Tax for the forthcoming financial year by the statutory deadline of the 11th March 2018.
