REPORT OF THE DIRECTOR OF LEGAL AND DEMOCRATIC SERVICES

1. <u>PURPOSE OF THE REPORT</u>

To provide Members with baseline information of performance indicator targets set by Council services for the 2015/16 financial year in order to help inform the scrutiny review of 'target setting arrangements'.

2. <u>RECOMMENDATIONS</u>

It is recommended that Members:

- 2.1 Agree a scope for the scrutiny review of target setting arrangements and the intended outcome(s) from the work;
- 2.2 Agree an approach to be taken to undertake the review and timescales; and
- 2.3 Select a range of performance indicators that will form the basis of the review (baseline analysis included as **Appendix 1**).

3. <u>SCRUTINY REVIEW - INFORMING THE SCOPE, APPROACH AND</u> <u>TARGETS TO REVIEW</u>

Background

3.1 At the Finance and Performance Scrutiny Committee on 16th September 2015, the Committee determined to undertake, amongst other things, a review of performance indicator targets set by the Council for the 2015/16 financial year.

Draft Scope

- 3.2 At the 16th September 2015 meeting, Members also considered a scope for the review, which was:
 - To review the extent of the Council's ambition in driving improved

performance through the setting of stretching targets; and

- To establish the extent to which the Council explains the reason(s) for the targeted levels of performance it aims to meet.
- 3.3 Members are requested to consider the above scope and determine whether it meets their intended requirements or if not, make amendments as deemed appropriate. Members are also requested to consider and set out an outcome or outcomes from the review, for example, an up date reported to Cabinet setting out a series of recommendations.

Approach to the review

- 3.4 At the Finance and Performance Scrutiny Committee of the 27th July 2015, a report was presented that set out key principles to consider when drafting scrutiny work programmes. In particular, paragraph 5.7 noted examples of different approaches that can be used when undertaking scrutiny reviews. A copy of this report can be access by clicking on the following Link.
- 3.5 Members are requested to consider this information as part of determining the approach to the review and associated timescales.

Targets to review

3.6 To aide Members consideration of targets to examine as part of the review, set out at Appendix 1 is a detailed analysis of performance indicator results and targets.

4. <u>CONCLUSION</u>

- 4.1 The Finance and Performance Scrutiny Committee will agree timetable of work at its meeting on 16th September 2015, one topic being to review target setting arrangements.
- 4.2 To progress the review, the Committee is requested to agree a scope, outcomes and approach, and also select a number of performance indicators to examine in more detail.
