<b>Review of Licensing Act 2003 &amp; Gambling Act 2005</b>	

**1. PURPOSE OF THE REPORT**

The purpose of the report is to update Members on relevant issues, with regard to

- **the Licensing Act 2003**
- **the Gambling Act 2005**

**2. RECOMMENDATION**

Members are requested to: -

- (i) note the contents of the report in respect of the **Licensing Act 2003** which has been provided for information;
- (ii) note the contents of the report in respect of the **Gambling Act 2005**, which has been provided for information;
- (iii) to note the comments of the Service Director Public Health & Protection in respect of the re adoption of the current Statement of Principles for the Gambling Act 2005, (subject to minor legislative amendments) and to commend this action to the Executive.

**3. BACKGROUND**

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this particular Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

#### 4. **LICENSING ACT 2003**

##### 4.1 **Application Process**

Applications received since the last update (**13th July 2015 to 4th October 2015**) are as follows:-

An analysis of Notices served confirms a fairly equal division of Notices between Qualifying Member Clubs (19); Community events (22) and existing Premises Licences (18). Of note in this quarter is the use of TEN's to facilitate trading where a Premise Licence application had lapsed.

The particular Premises Licence in question lapsed due to the death of a joint licensee and the remaining joint licensee omitted to notify the Licensing Authority within the statutory timescale. There is no discretion to reinstate a licence when lapsed and therefore it would be necessary to cease all licensable activity. Following a meeting with Licensing Officers to discuss the circumstances, advice was given in respect of the use of TEN's to facilitate continued trading whilst an application for a new licence was made. The licensee was particularly appreciative of the assistance provided, which enabled his business to continue whilst the new application was being processed. The new licence was issued 8/10/15, followed by a letter of thanks from the new licensee.

#### 4.5 Compliance & Enforcement

##### (i) Prosecutions

Details of Prosecutions under the Licensing Act 2003 are reproduced for information as **Appendix 1B**

##### (iv) Test Purchasing

Trading Standards Officers conducted 25 test purchases in the period, with one sale reported. The relevant Premises Licensee is currently the subject of investigation in respect of the sale of alcohol and other related matters in respect of the DPS in control at the time. (Enquiries are continuing.)

##### (v) Partnership Working

Licensing, Trading Standards, Environmental Health & Police Officers have also collaborated on the following issues:-

- Mediation meeting re 3 'S' Convenience Store & Premier Stores
- Advice /Guidance/Enforcement visit to Trallwn Workingmen's Club as a result of complaints received and limited response from Club Committee to concerns raised;

- Multi Agency enforcement exercise to the Mountain Ash East Ward, where information had been received regarding alleged under age sale of alcohol to young persons. (This followed a multi agency meeting with relevant licensees held at Aberdare Police Station on 27/7/15)  
As a result of the behaviour of several young persons witnessed that evening, Officers had cause to speak to Licensees/Club Premises Certificate Holders in several premises. (Enquiries and liaison with licensees is continuing.)

- Police & Crime Commissioners' Office - Violent Crime Reduction Initiative

Funding has been made available to facilitate additional enforcement work in advance of Rugby World Cup matches, the Six Nations Rugby Tournament and Christmas festivities. Officers have secured limited funding to support the use of Taxi Marshalls at Pontypridd town centre and Aberdare town centre on key dates. In addition Officers have participated in a number of proactive visits to the respective town centres to provide advice & guidance on :

- Serving alcohol to persons who may be intoxicated;
- additional staffing for key fixtures;
- use of SIA Door Staff
- use of non-glass drinking vessels;
- early liaison with SWP where problems occur

Visits were also conducted whilst events were in progress, in order to provide visible reassurance to licensees & customers. At the time of preparing this report, premises have been found to be generally compliant and there has been only one instance of a premises requiring further investigation.

- The Upper Rhondda Pubwatch - Dai Fib Appeal

Members may be aware of a recent initiative to provide Defibrillators in different types of premises where public have access and there are currently 2 licensed premises in this area which make this provision:

- Treherbert RFC, Treherbert
- The Lion, Treorchy

In addition the Upper Rhondda Pubwatch are launching a fundraising initiative during December 2015, with the aim to provide the community with a further 8 Defibrillators. The fundraising will include such things as a Penylan Santa Dash; Charity Raffle and a wide range of events.

Whilst the Licensing Authority is not responsible for the initiative, (which is being developed by licensees, in conjunction with South Wales Police) , advice, guidance and support will be provided by the Licensing Team , particularly in respect of permissions for charity collections, TEN's or other licensing related matters that may arise.

**(vi) Premises Inspection & Infringements**

54 premises were inspected in the last period, (primarily category A&B) and the programme continues utilising revised assessment format.

A summary of infringements arising from inspection is reproduced as **Appendix 1C**.

Matters of interest arising from recent inspections include a referral to the UK Border Agency for a restaurant, where there was evidence that the first floor area was being used as sleeping accommodation for ethnic minority/Asian persons, where no residential accommodation was recorded. (Further enquires ongoing.)

Members will be aware that Officers have authority to suspend licences where Annual fees remain unpaid, (subject to certain criteria.)

A review of activity up to 30th September 2015 confirms that 14 Premises Licences are currently suspended. However, 12 of the premises are no longer trading, (for a variety of reasons, such as change of ownership) and therefore there is limited impact to the suspension. In respect of such premises debt recovery action has also been initiated, to be pursued as a separate matter, in addition to any suspension action.

## 5.3 Enforcement

There are no enforcement issues to report for this period.

## 5.4 Gambling Licensing Policy Review 2016-2018

Members are advised that the Gambling Policy Statement is scheduled for review, (statutory requirement), where the revised policy has to be adopted for implementation in January 2016.

Having had regard to the advice of the Gambling Commission and current best practice, it is considered that the current Policy Statement continues to be fit for purpose, with the exception of minor amendments to reference legislative changes and revised Statutory Guidance which has recently been published.

Having regard to the minimal amendment, consistent with legislative change it is considered that consultation on the revision will NOT be required.

**In view of the very low profile that the Gambling trade currently has in Rhondda Cynon Taf it is therefore considered appropriate to commend the current policy to the Executive for re-adoption at this time.**

This will maintain the status of the current policy in accordance with statutory guidelines and will allow a revision of the policy in respect of social responsibility statements, (or other matters that become relevant), when active experience of same has evolved.

## **5.5 Recovery of Annual Fees**

As a result of the static nature of the trade, there is little change to the position, where 100% recovery of annual fees is the standard, primarily due to the robust provisions contained within the legislation which allow for withdrawal of the licence/permit for non-payment of appropriate fees.
